The W.J.C.C. agency represents more than 100,000 Yiddish Speaking Orthodox Jewish residents in Brooklyn. A large portion of this community resides in the 33rd Council District.

The new council district maps released on July 15th, 2022, divides the Jewish community into three separate districts. If the district boundaries in the area will remain as proposed, it will result in the removal of roughly a quarter of the community from the 33rd district into Council District 34, hence diluting the community's representation in the city council. We hereby appeal that our community is not divided and broken into several council districts.

Our community shares the same interests and needs. We share a religion and culture, as Orthodox and Hasidic Jews, that keep us united and together.

Our community has a strong voice in our current district. Splitting our community would dilute our united voice and will disenfranchise those who would be moved to a different district where they will be less than 10 percent of that district. This would have a devastating effect to the community's unique needs and concerns. This includes the elderly in the housing projects and our communities' children. We hope this will not happen.

Some of the key unifiers of our community of interest, is a high percentage of large families, Around 45 to 50% of the community being under the age of 18. The need for security and protection from anti-Semitic hate crimes, which is an ongoing issue in our neighborhood, the unique housing and zoning needs geared towards family and larger family housing; the unique religious practices and services; and Yiddish language social service delivery and advocacy system.

As said, the draft proposed maps eliminate a major part of the Hasidic area of Williamsburg from the 33rd district, where the majority of the community will remain.

The portion that was proposed in the released maps cut out a main part of the Hassidic section of Williamsburg.

The Area North of Ross Street that was removed from the 33rd district has thousands of private houses, condos and rentals,

mainly occupied by religious Orthodox Jewish families. Those blocs also maintain significant religious institution areas for the Williamsburg Jewish communities.

Many Synagogues, including the main Satmar shul which is still in the middle of construction.

This area includes four major public housing developments, with several thousands of low-income housing apartments, with a significant population of Orthodox Jewish families, and the only one of these types of public housing

in Brooklyn with a significant number of Orthodox Jewish families and individual residents.

These new lines also cut through the heart of the area where the community's majority of houses of worship are. Each of these synagogues has hundreds of daily worshippers. There are also tens of smaller synagogues.

The area also includes the heart of one of the community's main shopping strips, Lee Avenue, This area is where hundreds and thousands of the Hasidic families are doing their shopping daily.

In addition, the known Broadway triangle area between Broadway, Flushing and Union Avenues, an area Which was rezoned in the last 15 years, with the advocacy of the community to bring more housing to the neighborhood. This area has more than one thousand units, and a few more thousands units were completed since then. There is also currently another few thousand units in the middle of construction, which will be completed in the coming months.

These developments will include hundreds of large family units, 25% of affordable units. There are also many smaller synagogues in this area.

East of Nostrand Avenue, South of Myrtle Avenue to Dekalb Avenue.

This is where the community recently settled. It wasn't in the district before and now has approximately one thousand families of the Hasidic community.

This area is bordered by Tompkins and Nostrand Avenues,

Myrtle and Dekalb Avenues. between Flushing Avenue and Myrtle Avenue, between Nostrand Avenue and Marcy Avenue, this area has the Marcy houses.

This area includes the new Cascade Development, between Myrtle, Marcy, Stockton and Tompkins – with roughly 300 units, overwhelmingly occupied by Hasidic Jewish families. Cascade also has a large synagogue and a large kosher supermarket.

The area also has many smaller synagogues.

Additionally, this area includes other new developments with a large Hasidic population.

Myrtle Avenue and Vernon Street, Throop Avenue, with over a hundred units overwhelmingly occupied by families of the community.

It is very important to keep these areas connected to the district,

All these above-mentioned areas are a part of the Williamsburg Jewish neighborhood with a large majority of the Hasidic population and are culturally sensitive. We rely on the city councilmembers to focus their time to know, understand and actively advocate on behalf of our community, With the community being spread out in several districts it will be very hard and difficult to obtain the representation and attention to our needs and concerns.

Therefore, we hereby request and ask to keep our community together and to include and keep all these Hasidic populated areas united within and a part of the 33rd District



Dear Chairman Walcott,

As leaders of the Sephardic Jewish Community, we feel compelled to express our concern re the New York City Districting Commission's proposed maps.

First, a bit of background re the history of the migration of the Orthodox Sephardic Jews to the Brooklyn area. Our ancestors came to these shores in the early 1900's. After spending some years on the lower east side, they settled in Brooklyn. The community moved within Brooklyn until a major move to the Gravesend area in the mid 1940's. While the original migration was from Syria, Orthodox Jewish migrants from Egypt, Lebanon and Israel have joined our ranks. Due to an unprecedented growth in numbers, the community has spread to the Midwood, Homecrest and Madison neighborhoods.

It should be noted that the Sephardic community has long history of unique cultural attributes that differ from its Euro-centric Orthodox Jewish co-religionists. Throughout these years the core of the Sephardic community's major religious, social, educational and cultural institutions has always been and continue to be, centered within the current 47th Council District. For your information, the "mother" Synagogue, Shaare Zion Congregation, the Sephardic Community Center, Magen David Yeshivah, Ahi Ezer Yeshiva, Congregation Ahava Ve Ahva, Bnei Yoseph Congregation, Edmond J. Safra Congregation, Sephardic Congregation, Sephardic Lebanese Congregation Har Halebanon, The SAFE organization (substance abuse), and perhaps another dozen or more other key institutions are all located within the current 47th C.D.

We feel that the proposed map of the 47th Council District needs to be revised and changed to reflect the cultural, ethnic, and religious demographics of the Sephardic Jewish community that is heavily centered in the current 47th C.D. neighborhood.

The last proposed map of the 47th District included Bay Ridge that is a part of the Community Board 10 - far away from Coney Island, Sea Gate, Warbasse, Beach Haven and Gravesend. I strongly disagreed with previously proposed lines that also created a very odd shape of the 47th District. <u>Bay Ridge, Fort</u> <u>Hamilton and Dyker Heights should not be included in the 47th District!</u> These neighborhoods have very different demographics, issues and socioeconomic status. They are also located far away from Coney Island. I am very glad that the Commission rejected this plan.

The 47th Council District should unite Coney Island, Sea Gate and Warbasse Houses with neighboring Trump Village, Luna Park and Brightwater Towers.
