Open Letter to NYC Districting Commission

We, Southern Brooklyn Community Leaders, are writing to you to express our outrage that the Commission comple ignored countless testimonies from so many organizations, community leaders and other residents of Southern Brooklyn, asking to keep neighboring communities of interest together in the 47th District.

We represent the communities of Sea Gate, Coney Island, Warbasse, Beach Haven, Gravesend, Bensonhurst and E Beach. We wrote many letters to the Commission and testified in person. All our testimonies were disregarded. Instead of bringing together communities of interest, the Commission carved out four (!) neighborhoods from the District and connected Coney Island with Bay Ridge through a tiny, two blocks "tunnel" creating a very odd shape District.

We are very sympathetic and in full support of the idea of creating a new Asian American District. But it could be without tearing neighborhoods and communities apart. It is possible to do it without cutting several neighborhood of the 47th District.

We strongly oppose the last proposed map that cut Bensonhurst, Gravesend, Homecrest and Warbasse Houses of the 47th District. Instead, the Commission should include Sea Gate, Coney Island, Warbasse, Luna Park, parts of Brighton Beach, Gravesend, Bensonhurst and Bath Beach into one District.

Bay Ridge, Fort Hamilton and Dyker Heights should not be connected to Marlboro Houses and Coney Island in on Council District because they have very different demographics and socioeconomic status, located far away from other and have different issues and interests.

We request another public hearing of the Commission in Southern Brooklyn, so we can have a chance to express voice and to protect our communities.

I submitted testimony back in mid-May this year in support of an Asian majority district in Brooklyn; this has become a contentious issue for some current elected officials. Some want bits and parts for their own selfish purposes resulting in dividing up the Asian American residents who settled in various Brooklyn neighborhoods creating small enclaves of immigrants

Historically, the Manhattan Chinatown area was majority Asian American and slowly over the years, the area has changed. Newer, younger, more affluent residents have moved in and their concerns and political beliefs are vastly different from those living out their golden years in Chinatown. Historic Chinatown, a neighborhood that raised multiple generations of Asian Americans is now being violated by a tower jail being built and surrounded by homeless shelters for drug addicts and formerly incarcerated men. It seems that subsequent drafts of the new planned district maps have barely addressed our concerns.

There is one easy fix that would accommodate a number of member families in the community and eliminate an anomaly that has no good explanation.

This would be to move the planned easterly boundary of the 35th Council District one block further eastward to align with the natural boundary of the community at the edge of Lincoln Terrace Park (Rochester Avenue) and include one additional block of Union St, President St, Carroll St and Crown St., from Utica Ave to Rochester Avenue that are currently left out of the district where most of the members of their community are now located.

Dear Members of NYC Districting Commission! I am Grigoriy Berdichevskiy, Brighton Beach resident, member in the Russian speaking community. According to the City Charter, Council district lines should keep neighborhoods and communities of interest intact. They also should keep districts compact. The last proposed map of the 47th District included Bay Ridge that is a part of the Community Board 10 - far away from Coney Island, Sea Gate, Warbasse, Beach Haven and Gravesend. I strongly disagreed with new proposed lines that also created a very odd shape of the 47th District. Bay Ridge, Fort Hamilton and Dyker Heights should not be included in the 47th District! These neighborhoods have very different demographics, issues and socioeconomic status. They are also located far away from Coney Island. I am very glad that the Commission rejected this plan. The 47th Council District should unite Coney Island, Sea Gate and Warbasse Houses with neighboring Trump Village, Luna Park and Brightwater Towers. It also should include parts of Brighton Beach (from Ocean Parkway to Coney Island Avenue). These neighborhoods would be natural part of the 47th District given the similar demographics, local issues, close proximity and their traditional inclusion into the same Community Board 13, the 60th Police Precinct, the 46th Assembly District, the 23rd State Senate District and the 8th Congressional District. My name is Pinchas Ringel and I reside in the 44th council district.



We share the same synagogues, yeshiva schools, kosher food stores, shopping centers, and religious practices and observance. We are a concentrated community and are unique, sharing common values and having many of the same needs. It is therefore critical that our communities' unique characters be maintained in a manner where our ever-expanding communities need the attention of elected officials who understand and respond to our needs. The 44th City Council District, which, for decades at this point, has been the core Jewish City Council District and was the only district that had a Orthodox council member for over 3 decades.

During Friday hearing it was mentioned that letters were sent in to keep the Jewish community in one district but border lines weren't included. I'm including in this email an updated map that I just drafted from what was included in previous emails to the commission along with testimony.

To explain, Boro Park residents consider the boundaries of Boro Park from 36th Street all the way to 61 Street but in truth the lower numbers are really considered Kensington by the commission and is currently in the 39th district as you can see in the attached map. The proposed map includes this portion that is now in the 39th district that is heavily Hasidic area.

The area from Ditmas Avenue to Ave I, McDonald to Ocean Parkway especially the part that is currently in the 44th district is heavily populated with Hasidic and Orthodox Jews and all the new condos that were built in this area lately, are populated by the Hasidic community. The Commission on Friday ignored this and took the whole area out of the 44 and placed it into the 40.

Dear Commissioner Schneps;

My name is Michael Silverman and I am a life-long resident of Southern Brooklyn and reside in Warbasse Houses currently within the 47th Council District. In fact, I am the President of the Board of Directors of Warbasse Houses, the Parliamentarian for Community Board 13, a member of the 60th Precinct Community Council, and formerly the Democratic State Committeeman for the 46th Assembly District. Ten years ago I served on the SuperStorm Sandy Task Force in the City Council. I only include this information as background so as to inform you that I am truly involved in the community and know its people, residents, businesses, its needs, and certainly its boundaries.

I watched the Youtube video of the Commission's last meeting and found it very interesting and informative, but also found a rather large <u>error</u>, which would cause significant harm to the community and cause a miscalculation in the amount of residents in two council districts.

It is important to know the demographics of the district and their true boundaries, <u>without</u> <u>guessing</u>, which is why I address this letter to you as the "Brooklyn Commissioner". While I don't have access to your program/computer with maps and corresponding populations, I do know that when discussing Warbasse Houses in the 47th and moving it into the 48th, the commission used Ocean Parkway on the East, Mitchell Wesson (West Ave) on the North, Neptune Ave on the South, and West 5th St on the east (see video) and this is what they wanted to move into the 48th.

The boundaries are incorrect! You would be splitting Warbasse into two districts!

Warbasse is 26 acres and its boundaries are Ocean Parkway on the east, Mitchell Wesson (West Ave) on the North, Neptune Ave on the south and <u>West 6th St</u> (F train) on the west. The Commission's suggestion would place 3/5ths of Warbasse in the 48th council district and 2/5ths in the 47th council district. Warbasse Houses is 5 buildings with 2585 apartments, each building having 517 apartments each. Buildings 1,2 and 3 between Ocean Parkway and West 5th St have <u>155</u>1 apartments, and buildings 4 & 5 between West 5th St and West 6th St have 1034 apartments.

Best estimate on a Saturday night, would be an average minimum of 3 people in an apartment for a total of 1551 per building. Multiplying this number by the number of buildings (3) for a total of 4653 in just the portion of the complex that the commission added to the 48th will show that you undercounted the amount you added to the 48th, which would then cause it to be out of the range that you use as a guide. We have approximately 8000 residents here.

I listened to one of the Commissioners talk about the history of redistricting in the area with the last time being 10 years ago, and I remember it as well. It was redistricted via gerrymandering with heavy

political pressure to pretty much ensure that the incumbent politico in the then boundaries would not fall victim to the rising immigration/influx of our newest citizens. It would definitely be a shame if the current process allows political pressure and changes borders to suit some currently in power. That is not what the voters voted for. Currently we have seen the Commission step back and change a problematic revision where two incumbents would have to face one another, I'm sure this did not make either Councilmember happy and the Commission changed it. I understand how important it is to have a mostly Asian district, and you made it happen. I also understand how important it is to keep communities together like you did for Midwood and other mostly Jewish areas and you are to be commended for that as well. However, I will never understand how it makes sense to use one street in between two districts in order to connect the 47th between Coney Island and Dyker Heights/Bay Ridge.

This brings me to my suggestion, please consider keeping neighborhoods together by including Sea Gate, Coney Island, Luna Park, Warbasse, some of Brighton Beach (Brighton Beach Ave to Coney Island Ave), Marlboro Houses, Gravesend, and anything else up Cropsey Ave so that you have the needed population. We have similar needs, income levels and housing needs.

Let me explain, Warbasse is a State Mitchell-Lama Co-op(47th). Luna Park is a City Mitchell-Lama Co-op(48th), Sam Burt Houses in Coney Island is a City ML(47th), we all share many of the same issues and our buildings are of the same age and ethnicities. NYCHA represents a lot of the housing in Coney Island, Marlboro Houses is also NYCHA, and both groups share the same problems and have much in common. Whereas Trump Village, and Brightwater Towers (currently in the 48th) are private co-ops, share similar income levels and can be sold privately and should remain in the 48th. If it is necessary to increase the population of the 48th, since the district currently goes north as well, you can use more of the Dyker/Bayridge area there.

It is important to keep similar communities together, communities which at this point have been together for 10 years and even longer if we are talking about commonalities.



To Whom It May Concern,

As a member of the Orthodox Jewish Community in central Queens, I am aware of and grateful that the Redistricting Commission voted down the most recent (September 22nd) updated proposal for the redistricting map. In particular, I am saddened the disdain that the updated proposal shows toward the Orthodox Community in District 24.

When the initial redistricting plan was published, our Community was shocked to see the Hillcrest/Fresh Meadows Community – a pillar of the Orthodox Community – was completely removed from the 24th District, diluting our Community's ability to have its interests represented with a united voice. The Commission abysmally failed to meet the criterion set out "keep intact neighborhoods and communities with established ties of common interest and association, whether historical, racial, economic, ethnic, religious or other." As a member of the Orthodox Jewish Community in District 24, I am surprised that after so many pleas to preserve and keep our community together, the Commission presented a proposal on September 22nd that once again fails to preserve our Community.

Despite our efforts over the last 70 years to build and grow our Community in this Council District (District 24 in its current configuration is home to thousands of Orthodox Jewish families, almost a hundred Orthodox Synagogues, and many other Jewish Community centers and ritual facilities), our Community remains a distinct religious minority in this District, which demands that we be kept intact and retain the ability to be represented as one community. We have common concerns -- every one of our religious facilities is utilized every day of the week, multiple times a day; children and adults alike. By any meaningful metric, the Orthodox Jewish Community of District 24 is in a sustained period of growth, especially in the area that is proposed to be removed from the 24th District. I am therefore compelled to state the following:

The updated proposed redistricting maps for City Council are not in our Community's interest in their current form. The Jewish Community in the current configuration of Council District 24 is composed of the combined Sefardi and Ashkenazi communities. Our two communities are unified in interest and location, each with members and Shuls interspersed amongst each other. We are one contiguous chain linking together Kew Garden Hills, Fresh Meadows/Hillcrest, and Jamaica Estates. Though there are pockets of our community in other areas as well, this chain of neighborhoods represents the largest Jewish voice of Queens, and cutting any portion out would result in an unacceptable disenfranchisement.

The proposed change to the current District map completely disregards the reality on the ground. It artificially and needlessly separates many community members from the community facilities that serve them. Furthermore, the seemingly arbitrary lines harmfully cut off one community and congregation from its fellow community and congregation. The net result is a weakened Orthodox Jewish community, structurally, demographically, and politically.

The area of our Community that we seek to retain – the area east of Utopia Parkway all the way to the existing District boundary – comprises 3,888 people according to the Commission's numbers. So retaining 3,888 people to keep the Orthodox Jewish Community contiguous and intact the Commission won't do, yet the Commission seeks to ADD almost TWENTY SIX THOUSAND people to the 24th District from non-Jewish areas that are not currently part of the 24th District! This is adding insult to injury.

For these reasons I strongly believe that the redistricting proposal's continued disregard for the Jewish Community is damaging to the community's very fabric, its unified voice, and its interests. I implore the Redistricting Committee to keep to the criteria it is charged to uphold, immediately restore the 3,888 people in the area east of Utopia Parkway north of 75th Avenue and keep the eastern boundary of the District as it exists today.

We represent the communities of Sea Gate, Coney Island, Warbasse, Beach Haven, Gravesend, Bensonhurst and Bath Beach. We wrote many letters to the Commission and testified in person. All our testimonies were disregarded. Instead of bringing together communities of interest, the Commission carved out four (!) neighborhoods from the 47th District and connected Coney Island with Bay Ridge through a tiny, two blocks "tunnel" creating a very odd shape of the District.

We are very sympathetic and in full support of the idea of creating a new Asian American District. But it could be done without tearing neighborhoods and communities apart. It is possible to do it without cutting several neighborhoods out of the 47th District.

We strongly oppose the last proposed map that cut Bensonhurst, Gravesend, Homecrest, and Warbasse Houses out of the 47th District. Instead, the Commission should include Sea Gate, Coney Island, Warbasse, Luna Park, parts of Brighton Beach, Gravesend, Bensonhurst, and Bath Beach into one District.

Dear redistricting commision members,

We are very happy to see that the Redistricting Commission has recognized the need to create an Asian-majority district in South Brooklyn, however, it is quite disappointing to see the revised redistrict map continued to connect Bensonhurst with Sunset Park into the same city council districts. Bensonhurst and Sunset Park are both Asian community, however, the two different communities speaks different dialects. The culture and daily living practices are different. Reducing Bensonhurst to accommodate Sunset Park is wrong. Bensonhurst and Gravesend, historically has been together as one community. Gravesend also has a very large Asian population. As many Gravesend residents have expressed that they have always considered themselves as residence of Bensonhurst. Large part of Gravesend as asians, and should be in the same council district as Bensonhurst. We plead with the redistricting commission to connect adjacent communities of interest that shares the same language/dialect and cultural practices, in this case Bensonhurst and Gravesend. As one local teacher, Leon Cho, living in Gravesend has expressed his frustration with the map: "I have been living in Gravesend for over 15 year, and teaches at the local schools in Bensonhurst, I feel that we have been orphaned with this redistricting process. We need to be treated fairly, we need resources and funding in this fast growing community. We must do this (redistricting map) right. Another ten years is too long a wait." This same sentiments runs through the bloods of many Asians that resides in this community. Why do we need to share the same council district with Sunset Park that is quite a distance away, and sacrifice the connecting neighborhood of Gravesend, as Gravesend have a large Asian Population as well? We can not afford to wait another ten years to correct a mistake and put this great community in Jeopardy.
