Dear Members of the Districting Commission:

I am Dr. Tim Law and one of the community leaders in Brooklyn Bensonhurst.

I strongly opposed the proposed map of the 47th Council District. The new lines break neighborhoods and disenfranchise many communities of interest, divide families, schools and parks into five different districts. Bay Ridge was never part of the 47th District and should not be connected to Coney Island by a very long and thin corridor along 86th Street. Communities of Coney Island/Marlboro Houses should not be united in the same District with distant Bay Ridge because of their different socioeconomic status, local issues and demographics.

I also strongly believe that the Commission cut Warbasse Houses into two pieces diving five buildings of one housing coop between 47th and 48th Districts is wrong. They ignore the interests of Southern Brooklyn communities.

I urge the Commission to include in the 47th District neighboring, traditionally connected communities: Coney Island, Sea Gate, Luna Park, Warbasse Houses, Beach Haven, Parts of Gravesend, Homecrest, Bensonhurst, and Bath Beach. This way the 47th District map will look compact and communities inside the District will be intact.
