**INTRODUCTION**

The Prison Rape Elimination Act of 2003 (PREA Public Law 108-79) established federal mandates to identify and prevent prison rape in correctional facilities within the jurisdictions of federal, state, local, and native territories across the United States. Public Law 108-79 was signed into law on September 4, 2003.

The United States Department of Justice adopted the National Standards to Prevent, Detect, and Respond to Prison Rape (the PREA Standards) effective August 20, 2012. In addition to establishing mandatory standards for prevention, detection and response to prison sexual abuse and sexual harassment, the PREA Standards require all correctional facilities to conduct sexual abuse incident reviews and collect uniform data using standardized definitions. Agencies must ensure that data collection includes allegations of sexual abuse and sexual harassment at facilities under its direct control.

Pursuant to Local Law 21 of 2019, codified by section 9-156 of the NYC Administrative Code, the Department is required to report on allegations of sexual abuse and sexual harassment for cases that lasted longer than 90 days within the preceding six-month period, and for cases that were closed within the preceding six months. The following report outlines the aggregate number and percentage of the data required by subdivisions b and c of the law. Data that cannot be aggregated has been provided to the Council and the Board of Correction but has not been included in this report. Throughout both reporting periods, there were incidents involving less than 6 individuals; due to privacy concerns, the Department cannot publicly report any number less than six. This report, which evaluates sexual abuse and sexual harassment allegations made within the past six months (July 2022 to December 2022), analyzes emerging trends, and assesses the corrective action contemplated and/or initiated at the facility level and department wide. It is important to note that allegations of sexual abuse and sexual harassment are preliminary and subject to change as these cases develop. Data discussed in allegation categories are not final, as they are ongoing or pending resolution. Data used in this report reflects the most current information available at the time of publication.

**SECTION ONE: SUBDIVISION B**

The data in this section is related to alleged incidents of sexual abuse and harassment that occurred during the preceding six-month period for which an investigation lasted longer than 90 days.

1. The date on which the incident occurred and whether the incident took place between the times 7:00 AM and 3:00 PM, 3:00 PM and 11:00 PM, and 11:00 PM and 7:00 AM.<sup>1</sup>

During the first half of 2022, the majority (63.64%) of alleged incidents occurred during the 0700x1500 hours tour. Reports referencing the 0700x1500 tour make up half of the cases (50%) reported in that time frame during the second half of 2022. The time of an alleged incident is reported as unknown in instances in which the complainant did not report a time to the Investigation Division.

Between July 2022 to December 2022, the majority (58.87%) of concluded cases were alleged to have occurred between 0700 to 1500 hours. In the Second half of 2022, the Investigation Division improved its methods, applying additional scrutiny to review of Genetec footage and exploring additional investigatory avenues, which resulted in an increase in cases where the time was identified.

**SECTION FOUR: ASSESSMENT**

***Preliminary Trend Overview***

Based on a comparison of previously reported data from January 2022 – June 2022, there was an increase of PREA Reportable cases within the reporting period of July 2022 to December 2022 that did not close within a 90-day period. There were instances where cases were submitted and returned as the Investigation was deemed insufficient to close.

Overall, the number of PREA Reportable allegations increased during the July 2022 to December 2022 reporting period by twenty-seven percent (26.92% = one04 to one32). The Department is committed to investigating all claims of sexual harassment and abuse in a rigorous and timely manner and will continue to do so going forward. Every allegation required that two investigators respond to the facility to interview, conduct canvasses and collect pertinent documentation. The Division will continue to combat false reporting by working directly and persistently with the District Attorney's Office in the prosecution of founded allegations and false allegations, as appropriate.

This reporting period showed an increase of 64% (33 to 54) in allegations of staff-on-incarcerated individual sexual abuse and harassment cases. It is the Department's goal to achieve full compliance with all PREA standards, as well as to provide a safe environment for staff and incarcerated individuals. All efforts are made to properly record, evaluate, and fully investigate all allegations made by staff and individuals in our custody. This renewed focus on ensuring that all allegations are properly recorded and addressed may account for some of the increase in overall allegations noted during this reporting period.

With the high volume of allegations received, the investigators continue to carry high caseloads. Their caseload does not reflect the allegations that are immediate response dispatch and are later deemed to not fit the reporting criteria. An immediate response into an allegation consists of full background, review of person in custody phone calls, video review, alleged victim interview, alleged involved interview and canvas interviews. Follow-ups include, but are not limited to, staff statements and vouchering evidence. Hence, all allegations that are received and dispatched receive the same attention to detail to afford them a proper determination.

***Policy & Practice Overview***

The Department has taken a zero-tolerance policy with regard to sexual abuse and sexual harassment and has advanced measures to improve the ability for victims to report these allegations, using a dedicated hotline and posters placed in facilities listing the hotline number and detailing how to report an incident. The Department continues to stencil the zero-tolerance policy with telephone numbers for reporting allegations in the jail and court cells, housing areas, and in the corridors. Incarcerated individuals are also informed that they may call someone to report incidents of sexual abuse and harassment. The Department conducts in-person orientation with new admissions related to the zero-tolerance policy. This allows individuals to ask the PREA Standards and Compliance Unit staff questions during the orientation or privately at its conclusion. The PREA Standards and Compliance Unit, the PREA ID Unit, and LGBTQ+ Affairs staff work closely together to provide support to all incarcerated individuals, especially those that are most vulnerable to sexual abuse and harassment.

The Department continues to ensure staff are educated about PREA and aware of the zero-tolerance policy related to sexual abuse and harassment, starting at the Academy with each new recruit class, as well as all contractors and volunteers. All new employees receive training during their on-boarding process and receive mandatory re-training every two years. The training covers recognizing the signs of sexual abuse and what steps to take when an allegation is made (first responder duties). In addition to posters in the facilities detailing how to report an incident, the Department has strengthened our incarcerated individual grievance system to ensure that people in custody have an effective outlet to communicate and resolve issues of concern through a streamlined process.

The Department also provides specialized housing opportunities for particularly vulnerable populations, including transgender, gender non-binary, and intersex individuals (TGNBI), who are at heightened risk of sexual victimization. The Department evaluates each person in custody on a case-by case basis when making housing determinations, guided by PREA standards. The PREA Standards and Compliance Unit and the LGBTQ+ Affairs Unit provide support and work closely with the TGNBI population to address concerns related to sexual abuse and harassment. Additionally, the PREA Standards and Compliance Unit conducts weekly retaliation monitoring of those who have submitted sexual abuse and harassment complaints.

***Staffing***

As of the time of this report being published, the ID PREA Unit consists of one Assistant Commissioner, one Director, one Deputy Director, nine Supervising Investigators and 28 Investigators.

**SECTION FIVE: CORRECTIVE ACTION**

During this reporting period, approximately 44 PREA cases exceeded the 90-day closing time frame. Of those 44, 40 cases have been closed to date. Under the direction of the new PREA Unit leadership, a review of the existing ID PREA process was conducted to identify the inefficiencies that contributed to this lapse. Changes have been made to the way that cases are assigned to existing staff in order to minimize the impact of staff attrition and redeployment. To address the increase in case volume and to address the 90-day overdue cases, seven new investigators were added to the ID PREA Unit.

Additionally, a new Assistant Commissioner and Director of PREA were appointed during this reporting period to improve the level of management and accountability within the PREA Unit. Enhanced management and improved efficiency will allow the ID PREA Unit to continue its work towards compliance with all PREA standards. Retraining of ID investigators and refining effective practices continue to be a priority. The new executive management for ID PREA will continue the Department's efforts towards improving the timeliness and quality of investigations and move the Department closer to full compliance with PREA standards.
