

# Health care providers in New York City are required by law to report certain diseases and conditions to the New York City Health Department.

## CALL 866-692-3641 IMMEDIATELY UPON SUSPICION

- A suspected outbreak of diseases occurs in three or more people
- The unusual appearance of any disease or condition
- A newly apparent or emerging disease, or a syndrome of unknown cause that may be communicable
- Anthrax
- Arboviral infections, acute
- Botulism (infant, foodborne, and wound)
- Brucellosis
- Carbon monoxide poisoning
- Cholera
- Diphtheria
- Food poisoning occurring in two or more people
- Glanders
- Hantavirus disease
- Influenza, novel strain with pandemic potential
- Measles (rubeola)
- Melioidosis
- Meningococcal disease, invasive (including meningitis) Monkeypox
- Plague
- Poliomyelitis
- Q fever
- Rabies and exposure to rabies
- Ricin poisoning
- Rubella (German measles)
- Severe or novel coronavirus (e.g. SARS, MERS-CoV)
- Smallpox (variola)
- Staphylococcal enterotoxin B poisoning
- Staphylococcus aureus, vancomycin intermediate (VISA) and resistant (VRSA)

- Vaccinia disease (adverse events associated with smallpox vaccination)

upon suspicion of any of the following conditions if case is a food handler; is a staff member or child age 6 or younger in a school, day care, camp or other group setting; lives or works in a congregate residential setting (including correctional or homeless facilities); or works in oral health care. If case does not meet these risk-group criteria, report within 24 hours of confirmation using Reporting Central or mail or fax a Universal Reporting Form.

## OTHER REPORTING REQUIREMENTS

- **HIV and AIDS** - Report all diagnoses of HIV infection, HIV-related illness and AIDS within 14 days using the New York State Provider Report Form. Call 212-442-3388 for more information.
- **Immunization** - Report all immunizations given to individuals age 18 or younger within 14 days of administration to [Citywide Immunization Registry](#).
- **Animal Bites** - Report all animal bites within 24 hours of the event [online](#) or by calling 646-632-6074.
- **Window Falls** - Report when a child age 16 or younger falls from a window in a building with three or more dwellings by calling 646 - 632 - 6023, or call 800-222-1222 outside of business hours.
- **Lead** – Report blood lead levels of 5 mcg/dL or greater for all New York City residents within 24 hours. For children under 18, fax to 347-396-8935; for people over 18, fax to 646-632-6105.
- **Poisoning by drugs or other toxic agents** – Call 800-222-1222 within 24 hours.
- **Psychosis** – Report first hospital admission of people ages 18 to 30 with psychosis diagnosis.
- **Sterilization** – Report all sterilizations electronically via [Reporting Central](#) monthly.
- **Deaths, Births, Termination of Pregnancy** – Use eVital to report births within five business days; report deaths within 24 hours; report termination of pregnancy within 24 hours if a burial permit is requested, otherwise, report within five business days.
