### **Intern Description**

The New York City Department of Investigation (DOI) is one of the oldest law enforcement agencies in the country with a mission of combating municipal corruption. It serves the people of New York City by acting as an independent and nonpartisan watchdog for New York City government, City agencies, and City employees, vendors with City contracts, individuals and entities that receive City funds.

DOI seeks a Data Analyst intern who will assist the Data Analytics Unit in its activities to support Investigators across multiple Squads. The role of the intern will include the collection, transformation and analysis of data. In performing such duties, the intern will have to seek resources for information such as publicly available repositories, repositories from other agencies, request for data from other parties, etc. Once data is acquired, he/she will be expected to load the data into a database and analyze it for accuracy and completeness. After all checks have been made, further exploratory analysis should be conducted such as identifying outliers. The intern will be required to clearly articulate all steps taken to acquire, load, transform and analyze the data.

If selected, the intern will be fingerprinted and undergo a background investigation. In addition, for positions that have a law enforcement and/or investigative function, the candidate's consumer credit history will be reviewed during the background investigation, and as otherwise permitted by NYC Administrative Code § 8-107(24)(b)(2)(A)
