#### DOI APPOINTS JEANENE L. BARRETT AS INSPECTOR GENERAL FOR THE NEW YORK CITY POLICE DEPARTMENT

Jocelyn E. Strauber, Commissioner of the New York City Department of Investigation ("DOI"), announced today the appointment of Jeanene L. Barrett as the Inspector General ("IG") for DOI's Office of the Inspector General for the NYPD ("OIG-NYPD"). IG Barrett's 20-plus years of professional experience includes nearly a decade in the field of police oversight and reform in New York City and extensive work in the area of criminal justice, as well as supporting underserved communities in New York City and Chicago, and in particular, children in crisis. IG Barrett came to DOI's OIG-NYPD in 2019 as the Deputy Inspector General for Policy Analysis and was promoted to First Deputy Inspector General in 2020. As Acting Inspector General since January 2022, she has overseen an array of matters, among them four investigations that resulted in three reports and a Statement of Findings, on topics including the NYPD's Criminal Group Database and the correlation between NYPD overtime hours and negative policing outcomes.

IG Barrett holds a Ph.D. in Criminal Justice, a Master of Philosophy in Criminal Justice, a Master of Arts in Social Work, and a Master of Science in Human Services Administration. Earlier in her career, she conducted extensive life history investigations as a mitigation specialist handling death penalty cases, examined issues impacting youth in Chicago as a policy consultant and, in connection with her work in the Illinois child welfare system, protected children at risk of abuse and neglect and provided support to families in need.

DOI's Office of the Inspector General for the NYPD was established in 2014 and was created by Local Law 70, which empowered the DOI Commissioner to "investigate, review, study, audit and make recommendations relating to the operations, policies, programs and practices, including ongoing partnerships with other law enforcement agencies, of the [N]ew [Y]ork [C]ity [P]olice [D]epartment with the goal of enhancing the effectiveness of the [D]epartment, increasing public safety, protecting civil liberties and civil rights, and increasing the public's confidence in the police force, thus building stronger police-community relations." Local Law 70 is now a part of Chapter 34 in the New York City Charter, which provides DOI with its charter mandate and authority.

DOI Commissioner Jocelyn E. Strauber said, "Jeanene Barrett has more than 20 years of experience that includes police oversight and accountability, community engagement, and supporting underserved communities. She has distinguished herself as a skilled and dedicated leader in the Office of the Inspector General for the NYPD, advancing complex investigations that have resulted in meaningful recommendations for reform. She has built strong relationships with the NYPD and the community, and she is the right choice to lead this critical Office in the Department of Investigation. I am thankful for her dedication to this work and to this agency, and thrilled to announce her appointment to be Inspector General for the NYPD."

Inspector General Jeanene Barrett said, "My career has been focused on an array of criminal justice issues that include policing and oversight, as well as how analysis and community engagement play important roles in effecting reform. OIG-NYPD has come far over the past nine years, and I am excited to lead the dynamic team into the future. I am thankful to Commissioner Strauber for this opportunity and am honored to advance this very significant work."

#### About Jeanene L. Barrett

Inspector General (IG) Barrett came to DOI's OIG-NYPD in 2019 as the Deputy Inspector General for Policy Analysis and was promoted to First Deputy Inspector General in 2020. She has served as Acting Inspector General for the OIG-NYPD since January 2022 and during that time oversaw numerous investigations, the release of three reports and a Statement of Findings including, "<u>An Investigation into NYPD's Criminal Group Database</u>" and "<u>Overtime Under Review</u>: NYPD Overtime and the Increased Risk of Negative Policing Outcomes," as well as two Annual Reports.

Prior to joining DOI, IG Barrett worked for Judicial, Arbitration, and Mediation Services (JAMS) as the Project Manager for the New York City Stop & Frisk Joint Remedial Process. This comprehensive community engagement process resulted in a final report that included 14 recommendations and 12 policy considerations for reforms to the NYPD. She has also conducted extensive life history investigations as a mitigation specialist on death penalty cases and worked as a policy consultant examining issues impacting young people between the ages of six and 24 in the city of Chicago. She began her career in the mid-1990s with the Illinois child welfare system, protecting children who were at risk of abuse or neglect and supporting families in need of assistance.

In addition to her work in New York City and Chicago, since 2003 IG Barrett has taught college courses on topics including criminal justice, policing, statistical methods and qualitative research methods.

IG Barrett holds a Ph.D. in Criminal Justice from the CUNY Graduate Center - John Jay College of Criminal Justice. She has a Master of Philosophy in Criminal Justice from the CUNY Graduate Center; a Master of Arts in Social Work from the University of Chicago; and a Master of Science in Human Services Administration from Spertus Institute in Chicago. She received her Bachelor of Science degree in Administration of Justice from Southern Illinois University at Carbondale.
