Local Law No. 85 for the year 2023 (Local Law 85) requires the Department of Sanitation (DSNY) to establish a mandatory citywide organics collection program. This program will make the source separation of residential organic waste in the City of New York mandatory. The law requires DSNY to implement the mandatory organics collection program in 30 residential sanitation districts by October 2, 2023, and in all remaining sanitation districts by October 7, 2024. DSNY's current rules provide that source separation of yard waste from organic waste is required in all districts in Staten Island and the Bronx beginning March 25,

2024, and in all districts in Manhattan beginning October 7, 2024. As a result of budget constraints, DSNY has determined to amend the date on which mandatory source separation of residential organic waste commences in all such districts in Staten Island, the Bronx and Manhattan to October 6, 2024.
