Our model is K-8. Can we apply for all of these grades despite what the attachment states? At what point do we need the written permission from DYCD for this model (as part of the application or post-award)? Which program model should our proposal be under for an all grades program (SONYC or COMPASS)?

Receptionist: Can we assign the receptionist more responsibilities than greeting participants, providing information, and signing participants in/out? Like office/administrative work?

Security Guard: Our center-based program is in a city-owned building and DCAS already provides a security guard. Is it OK if we just note this in our response or does the security guard have to be on our staff? And do we still have to provide a job description for this role? Janitor: The janitor is listed as part time – Does this mean only during program hours?

Bronx CD 12, which has community centers and other spaces that could support OST programs, has no slots emanating from this RFP.

There is no education or credential requirements for the Inclusion Coordinator position, but as stated in the RFP, the designee should be assumed by a senior-level staff member such as the Program Director. A contractors' budget can be used for rent. Total funding is calculated by multiplying annual Price per Participant (PPP) multiplied by the number of slots. Included in the budget should be costs associated with the budget that enable the effective delivery of services for the proposed program, including any indirect costs.

14:48:28 From Blake Smith: Regarding Professional Development: Does it have to be 3 PD hours every week or can we hold more intensive trainings where we do more than 3 PD hours one week and less than 3 PD hours the next week (as long as over the course of the year these add up to at least 129/108 hours)? Also, does prep time and lesson planning count toward PD (when done individually or as a group)?

There is no cap. Contractors would receive the Price per Participant (PPP) listed in the RFP multiplied by the number of awarded slots.

Proposers are not required to select a SEL curriculum in their proposal. As per the questionnaire, proposers are asked to describe the process they would undertake to select and implement a SEL curriculum, including the criteria they would utilize to assess curricula and any activities that would be included in addition to curriculum implementation. Proposers will be required to select a curriculum prior to the start of the program. DYCD will review and approve contractors selected SEL curriculum post-award.

However, since the submission instructions specify that all forms must be combined into a single PDF, any text entered beyond the visible field does not appear when printed. A plus sign appears on the form indicating additional text is present. Should we limit our responses to the visible space provided, or will a revised form be issued to accommodate the full responses?

Training does not have to occur on a weekly basis. As per the RFP, contractors will be required to provide at least 129 hours annually of professional development for COMPASS Elementary programs (or 3 hours per week) and 108 hours annually for SONYC programs (or 3 hours per week).
