DYCD defines "community partnership" as an agreement with an external entity (e.g., an organization/agency separate from the proposer). Organizations cannot utilize Departments within their organization to fulfill the Community Partnership requirement. Examples of the types of partnerships DYCD is looking for can be found on page 28. Independent contractors could count if it meets the expectations outlined in the RFP.

Budget narratives should present the costs to provide services for the proposed program(s) in the proposed annual budget, which could include subcontractors if applicable.

Hi Danice Crump - LEAP: With respect to slot counts, often in partnership with our NYCPS school partners, we work in partnership to determine slot counts that are realistic for the school community; however, as it is being explained, DYCD is requesting the submission of a budget based on a slot count that aligns with the industry standard of servicing roughly 35-40% of the community. As this often runs counter to conversations with NYCPS school building leaders, is there a desire on DYCDs behalf to submit a budget example that may not be in line with the negotiated slot count for the respective school?
