



## Local Law 79 Runaway and Homeless Youth (RHY) Services Access Report July 1, 2023 to December 31, 2023 Summary to the NYC Council

DYCD funds Runaway and Homeless Youth Services, including residential programs for youth ages 16 - 24<sup>i</sup>. DYCD funded Drop-in Center, Crisis Services and TIL Support Program providers are required to report each young person who is unable to access an RHY bed on the date they sought services.

RHY providers report daily bed availability over the six-month report period. During the period of July 1 to December 31, 2023<sup>ii</sup>:

- 1,322 young people were placed in a crisis services or transitional independent living support program.
- Due to individual preference, 2 youths declined a RHY funded bed. The remaining 2 youths decline placement when unable to be placed together as a couple and family.
- DYCD programs reported 236 encounters with youth who were not able to be matched to a DYCD funded bed on the day they sought placement.
- Ninety-seven percent of youth (228) that were turned away requested a male bed.
- Additionally, 40% of youth (93) were age-eligible for DYCD funded HYA beds that serve 60 young people 21 – 24.
- Over the six-month period, 37 young people visited a drop-in center on more than one occasion to seek residential placement. Of those young people, 38% were over age 21.
- Two youth under the age of 18 were reconnected to ACS placements.

DYCD will continue to monitor service referrals to ensure that placement protocols are followed.

<sup>i</sup> DYCD funds a total of 813 residential beds. Of that total, 60 beds are allocated for young adults (HYA) ages 21 – 24. There are 91 beds allocated for parenting youth and their dependent children. Forty-six of those beds are allocated for parenting youths’ dependent children.

<sup>ii</sup> The Department separately received information from organizations outside of DYCD provider organizations that notes youth who were unable to access shelter. Those advocates had at least 246 encounters with 237 individual youth seeking shelter who could not be immediately placed. Like youth reporting to RHY programs, Advocates indicate a significant majority, 98% of encountered youths, requested a male bed. In comparison, a greater percentage - approximately 43% of young-people assisted by Advocates were over the age of 21, thereby age-eligible for HYA residential program beds.
