Heat Emergency Plan: Local Law 85 of 2020

Summary

NYC Emergency Management (NYCEM), with the Department of Health and Mental Hygiene (DOHMH) and other sibling agencies, has plans and protocols in place to guide New York City's response to heat emergencies, including plans for cooling the public, messaging, and providing guidance to individuals, agencies, and the private sector on suggested safe behavior during periods of extreme heat.

Heat-Related Terminology and Triggers

- **Heat Index:** an estimate of how it feels when air temperature and humidity are combined. See [the National Weather Service Heat Index Chart](#) for more information.
- **Heat Wave:** in New York City, a heat wave is defined as at least three consecutive days with high temperatures of at least 90°F.
- **Heat Advisory:** issued by the National Weather Service up to 48 hours in advance when there is at least 80% confidence that the heat index is forecast will reach 95°F to 99°F for at least two consecutive days or 100°F to 104°F for any length of time.
- **Excessive Heat Watch:** issued by the National Weather Service up to 48 hours in advance when there is at least 50% confidence that the heat index values are forecast will reach or exceed 105°F for at least two consecutive hours within the next 24-48 hours.
- **Excessive Heat Warning:** issued by the National Weather Service up to 48 hours in advance when there is at least 80% confidence that the heat index is forecast will reach or exceed 105°F for at least two consecutive hours within the next 24 hours.
- **Air Quality Index:** reports how clear or polluted the air is. It is issued by the New York State Department of Environmental Conservation and relayed by the National Weather Service.
- **Triggers for Activating the City's [Heat Emergency Plan](#):**
 - Predicted heat index of 95°F or higher for two days or more
 - Predicted heat index of 100°F or higher for one day or more

Assessment of Cooling Needs

The New York City Heat Vulnerability Index (HVI) compares the risk of dying during and immediately after an extreme heat event across NYC neighborhoods. Developed by the DOHMH and Columbia University, the HVI is based on an analysis of heat-related mortality in New York City. The HVI helps the City prioritize resources to neighborhoods identified as having a high risk of the adverse health impacts of extreme heat. Through its comprehensive Cool Neighborhoods NYC initiative, the City has taken proactive steps to keep New York City communities safe during extreme heat events. These actions include programming to promote community resiliency through increased social cohesion, outreach efforts to educate residents about heat risks and resources, such cooling assistance available through the Home Energy Assistance Program, coating roofs white, and planting street trees through Cool Neighborhoods NYC.

Heat exposure can lead to heat-related illness or worsen existing chronic conditions, sometimes leading to death. In New York City, most heat-stress deaths happen after exposure to heat in un-air conditioned homes among people who have one or more other risk factors. These risk factors are older age (60+ years), having a chronic medical conditions or serious mental health condition, socially isolated or with limited mobility, alcohol or drug misuse, or taking medications that impact a person's ability to stay cool. Access to air conditioning is the primary intervention for preventing heat-related deaths. Approximately 10% of city households do not have air conditioning. Access is lowest among low-income households and Latino and Black New Yorkers. For New Yorkers without access to a safe home environment during extreme heat, the City provides cooling centers where anyone can access air conditioning and reduce their risk.

According to the NYC DOHMH, structural and institutional racism directly impacts both individual and community risk during an extreme heat event. Legacies of underinvestment in Black and Latino neighborhoods, compounded by systems of

oppression deeply woven into existing social, economic, and health systems, contribute to vast inequities across our city. These inequities, including access to resources that protect health such as economic opportunities and jobs that pay a living wage, present significant barriers for individuals and communities to accessing home cooling, a key intervention in decreasing heat-related illness and death. Limited resources also contribute to higher burdens of chronic medical conditions among Black New Yorkers. As a result, Black New Yorkers are more likely to die during extreme heat than other New Yorkers, and communities with a higher percentage of Black residents have higher neighborhood-level heat risks.

Public Outreach and Communication

Overview

When the City's *Heat Emergency Plan* is activated, verified and approved messaging can be disseminated through citywide channels, including press releases, NYC.gov websites, Notify NYC, NYC Advance Warning System, 311, and social media channels. City agencies' respective press and communications teams are chiefly responsible for ensuring messaging is accurate, timely, consistent, and accessible to the whole community.

NYC Emergency Management Communications

- **Notify NYC:** Notify NYC is New York City's official source for information about emergency events and important City services. Notify NYC will strategically message subscribers about impacts to area and community, etc. Notify NYC notifications are available in 13 different languages and American Sign Language (ASL) video format. Visit [NYC.gov/notifynyc](https://nyc.gov/notifynyc) for more information.
- **Media:** Through its press office, NYCEM will coordinate press releases and inquiries relating to the event, as well as press briefings/conferences for the City's response. Press releases and information will be shared with media, community partners, private-sector partners, etc., as needed.
- **Non-English speakers:** NYCEM seeks to engage with local and ethnic media and employs several individuals who speak languages other than English who

will appear on ethnic TV or radio to disseminate information. Additionally, Ready New York outreach materials surrounding emergency planning, including extreme heat, are available online in a number of different languages. NYCEM also works with the DOHMH and the Mayor's Office of Immigrant Affairs on a regular basis to best address the needs of the City's non-English speaking neighbors.

- **Language Access:** NYCEM is in compliance with Local Law 30 of 2017 which requires the designation of ten languages for which all covered agencies would be required to provide language access services.
- **Elected Official Outreach:** Agencies will inform local elected officials of the incident and related impacts to residents/communities. The opening of public sites will be briefed on elected official calls.

NYC Department of Health and Mental Hygiene Communications

- **Health Alert Network (HAN):** The Health Alert Network (HAN) shares public health information, including health information related to emergencies, with medical providers. This includes up-to-date health alert information, an online document library on public health topics, and an online community to exchange information and ideas with colleagues. - **Mass Communication to Community Partners:** DOHMH's Office of Emergency Preparedness and Response (OEPR) sends a mass email to community partners from across the entire agency, including community- and faith-based organizations, and houses of worship, and faith-based organizations, through Public Health Partners Connect. DOHMH's Be a Buddy (BaB) program notifies partners of the heat activation, which launches a network of volunteers to check in on residents at higher risk during heat events within BaB communities. Within DOHMH's Center for Health Equity and Community Wellness (CHECW), the Neighborhood Health Action Centers, , located in high HVI areas, are alerted and messaging in their communities, and as well as their Office of Faith-Based Initiatives, which alerts their expansive network of engaged and trained house of worship partners.
- **Heat Health Training:** The heat health training is a curriculum that was created by DOHMH and the Mayor's Office of Climate Resiliency to train "trusted

messengers,” such as home health aides and community health workers, about how to keep their clients safe during extreme heat events. The training can also be tailored for different audiences with less medical background including faith leaders/houses of worship and community-based organizations (CBOs). Before the COVID-19 pandemic, the Mayor’s Office of Climate Resiliency hosted a series of these training sessions at Neighborhood Health Action Centers in heat-vulnerable neighborhoods. In 2020, DOHMH, NYCEM (Community Preparedness) and the Mayor’s Office of Climate Resiliency collaborated to deliver the training virtually, and will do so again in 2021.

Citywide Messaging Strategies

- **NYC 311 Messaging and Coordination:** City agencies will work closely with 311 to ensure updates are made related to the incident.
- **Website Management, Development, and Messaging:** Agency websites will reflect updates on the incident as needed.
- **Social Media:** To ensure that a consistent, unified message is communicated through social media channels, City agencies will amplify information regarding the incident and related impacts to residents/communities. Public-facing links to these items, where applicable, can be found below:

 - Be a Buddy social networks: The Be a Buddy (BaB) pilot program partners with community-based organizations in the high-HVI communities of Brownsville, East Harlem and Hunts Point to
 - Identify community residents who are at higher risk for heat-related death and illness;
 - Engage the higher-risk residents during non-emergency “blue-sky” periods to increase community social cohesion; and
 - Activate a local volunteer base to perform “buddy” checks on the identified higher-risk residents during heat events and other emergencies.
 - Since its launch in May 2018, Be a Buddy community-based organization partners have identified over 1,300 residents at higher risk for heat-related death and illness during a heat event, hosted more than 500 engagement events, and conducted over 13,000 check-ins for emergencies including heat events, winter storms, freezing temperatures, and COVID-19-response.
 - Home Health Aide Training: Half-day training sessions are offered to home health aide agencies for staff to learn more about the risks of extreme heat, how to identify clients who are at higher risk, heat safety first aid, and mitigation strategies.
 - House of Worship Training: Half-day training sessions are offered for house of worship leadership who provide home-ministry or equivalent services. Training includes the risks of extreme heat, how to identify congregants at higher risk and how to conduct wellness checks during heat events, basic heat safety first aid, and mitigation strategies.
- Homeless Individuals: During a heat emergency, a Code Red may be issued which makes shelter available system-wide to accommodate anyone homeless. Outreach teams will contact vulnerable individuals on their Code Red priority lists to encourage them to accept services, including transportation to shelter placement. Accommodations are also available for walk-ins.

Office Building Energy Reduction

In the event of the City activating the *Heat Emergency Plan* and an Extreme Heat Emergency Declaration by [Executive Order](#), City agencies are required to set municipal building thermostats to 78 degrees or higher. Owners of private office buildings that are 25,000 square feet or greater will also be required to set thermostats to 78 degrees or higher. Exemptions will be made for certain buildings that provide critical health or disability services or buildings that have critical equipment that require certain levels of cooling. The mandate would be in effect for the extent of the heat wave or heat advisory. To promote greater compliance private building landlords are encouraged to send notices to office tenants of the heat wave/heat advisory event and the thermostat requirements. Physical signage in buildings is also encouraged.

Cooling Centers

Safety

Cooling centers are air-conditioned spaces, such as older adult centers, community centers, public libraries, and other public facilities that typically operate during daytime hours and are free and open to the public. Cooling centers are facilities managed by agency partners who determine each site's hours of operation and level(s) of accessibility. Given this, a cooling center may not be available for several reasons, including, but not limited to, a designated space being used for another purpose, an ongoing capital improvement, a broken air conditioner, and the inability to maintain appropriate physical distancing within the facility in compliance with local, state, and federal guidelines related to COVID-19.

Cooling centers that are available for public use will be listed on the [Cooling Center Finder](#), an online tool where New Yorkers can see what cooling centers are open during a heat emergency. NYCEM, the Mayor's Office of Resiliency, and DOHMH are working together to expand the number of cooling centers throughout the city using the HVI as a guide. New Yorkers also may call 311 for this information.

Disease Control Guidelines

All cooling centers are required to comply with local, state, and federal laws, rules, and regulations regarding infection control, including ventilation, social distancing, face-covering compliance, and disinfection protocols. This includes, but is not limited to:

- Physical distancing and occupancy guidance from DOHMH will be provided at the time of activation. Cooling centers must have capacity to modify the space to allow people to sit physical distanced from each other unless they are from the same household. At least one physical distancing sign will be posted in each common area. Cooling centers will plan for occupancy with reduced capacity in order to adhere to physical distancing guidance.
- Centers will follow current guidance on best ventilation practices from DOHMH and the Centers for Disease Control and Prevention at time of activation.
- Restrooms will be offered with adequate hand-washing facilities, including soap, working faucets and drying materials. A handwashing sign will be posted in every restroom or near hand-washing areas.
- Accessible drinking water will be available for visitors. Paper cups will be available to people who cannot access a drinking fountain.
- Cleaning and disinfection will occur regularly. High-touch areas will be disinfected at least daily.
- NYCEM will coordinate with facility management and DOHMH to provide any necessary training — virtual or in-person — for health-related safety, if special requirements are established for cooling center use.
- Staff, volunteers, and visitors will be told to remain at home if sick.
- DOHMH guidelines regarding face coverings provided at the time of cooling center activation must be followed. Staff, volunteers, and visitors may be required to wear face coverings, in which case face coverings will be provided to people who do not have one available.

Potential Cooling Centers as of May 15, 2021

Please see Exhibit 1 following this report, current data as of May 15, 2021. Cooling centers are facilities managed by partners who determine each site's hours of operation and level(s) of accessibility. Due to current restrictions related to COVID-19, some partners are unable to participate this year.

Please note that a site's designation for potential use as a cooling center **does not** mean that the site will be used every time there is a heat emergency and this list should **not** be used as a guide nor should it be disseminated publicly. Rather, the public is encouraged through messaging to check the Cooling Center Finder online or call 311, to find out which cooling centers are available to them at that time as sites come online or offline continuously.

When activated, the [Cooling Center Finder](#) is updated continuously during the heat emergency in real time.

When the Cooling Center Finder is not activated, the website will read: “**At this time, the Cooling Center Finder application is NOT activated.** A cooling center is a facility, such as a senior center or community center, where people may go to enjoy air-conditioned comfort during a heat emergency. There are many cooling centers around the City, most of which are open during regular business hours in case of a heat wave.”

Please note that the capacity noted below may be impacted by COVID-19 restrictions.
