

Overview of Contracts

Project Area 1 (PA1)

NTP issued August 2021

- Partial Closures:
 - East River Park south of E. Houston St.
 - Greenway closure to E. 10th St.
 - Corlears Hook Park
 - East River Park north of Track to close May 27
- Bridges: Corlears Hook pedestrian bridge installed. Use Corlears Hook temporary ped. bridge. Delancey St. bridge Open!
- Ongoing work:
 - Floodwall activities, as well as fill operation via barge
 - E. Houston St. retaining wall work
 - Ballfields 7 & 8 deep sewer work
- Amenities in progress:
 - Phase 1 amenities opening May 26!
 - Amphitheater, north Tennis Courts and esplanade reconstruction







- 5. Road restoration work, including utility and sidewalk installation.


- Tennis Court construction. Paver installation.





Excavations are required to accommodate Con Edison gas and electrical crossings into East River Park


- Began Monday, May 19, 2025

Fireboat House:

- City responded to comments from Consulting Parties on April 30
- CAG is a Consulting Party
- City to schedule meeting with SHPO and the Consulting Parties to discuss possible mitigation options, which will be set forth in a new Amendment to the Programmatic Agreement
- Fireboat House cannot be safely opened to the public with other amenity openings

NYSDEC/NYCDEP SWPPP Violation:

- Issued on 1/6/2022 for inadequate erosion control measures and 5-acre variance
- Violations rectified within two months and 5-acre variance issued on 11/4/2022 by DEP
- 2025 settled fines

Restoration of Gouv. Slip E.


- Concrete road base installed



- This activity is weather-permitting


Jackson St. Daytime Closure
