4	09/27/21–10/08/21	7:00 am to 3:30 pm 10:00 pm to 5:00 am	West Service Rd between E 25 Street and E 23 Street	Pile installation for the floodwall ongoing. ** Night work continues

6	09/27/21–10/08/21	7:00 am to 3:30 pm	E 20 Street and Avenue C Intersection	ConEdison utility work continues.

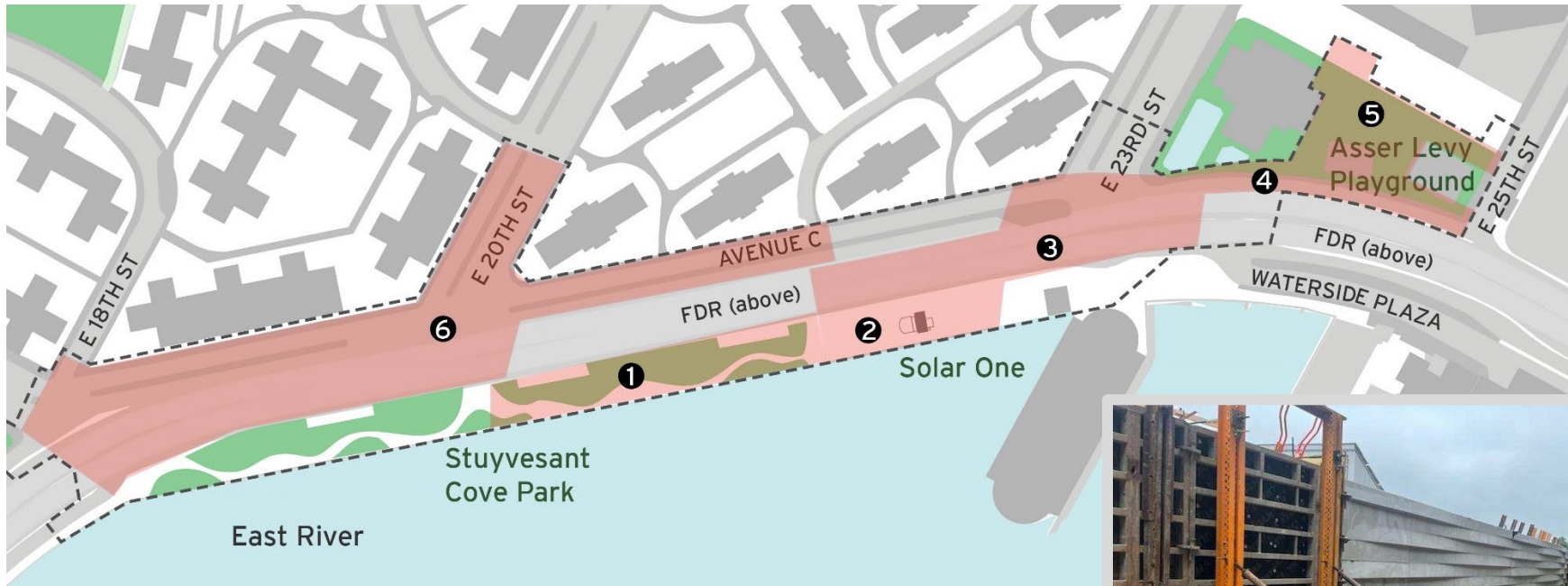
