Q & A

Wendy: What is the plan once the at the Lewis entrance is done? How will that area be made into more of a park entrance? Most people still don't realize you can get through there.

Ethan: I'll make sure we have additional signage there to direct people into the park. We'll get back to you on the final signage and striping plan there.

Wendy: When you're on the Delancey Bridge and look down, you can see a wide path next to the FDR on the river side. What is the plan for that area?

Ethan: That will remain a construction road throughout construction, but when we're done portions of it will be open for pedestrians, and other parts will be limited to Parks access.

Wendy: So it's not a bikeway?

Ethan: Not to my knowledge, but I can look into the specifics and get back to you.

Wendy: Regarding the air quality alerts near 10th Street, will there be more work that will continue to make it reach notable levels?

Ethan: To clarify, those specific alerts are for monitors on the park side. I imagine there's more work to do there, so we'll remind the contractor about dust mitigation measures. At E. 10th Street near Riis, there is quite a bit more work to do there. Installing the approaches for the bridge will be pretty noisy and messy. That's why we've been moving some vibration monitors and adding some air quality monitors up there. We're in close contact with Riis, so we'll be sure to keep them informed as work approaches.

Julian Swearengin (Friends of Corlears Hook Park): I wanted to ask about what we call the "FDR pathway" – it's along the drive's west side and goes under the bridge. It used to be a Chinese garden, but now it's an unplanted pathway. Is there a plan for filling that in?

Ethan: Yes, there is a plan, and Luc Alicea of Parks (who's not here today) will email you folks about this soon.

Julian: I also wanted to flag an issue with two spots we've noticed in Corlears Hook Park. One of them is right in front of the dog run--and one of them is opposite--where rain seems to pool and it floods.

Ethan: Yes, thank you, we are aware of that and are looking into it.

Wendy: Do the contractors have a one- or two-year responsibility for the trees?

Ethan: Shrubs, grasses, and perennials are 18 months, and trees are 24 months. I would have to look into when this period goes into effect (i.e., from when they're planted or a different time).

CAG-only Portion

Paula: A few CAG members and I walked around the park on Tuesday to look at areas that are critically lacking in shade as we wait for the newly planted trees to be mature enough to provide it. Wendy, do you want to share some takeaways?

Wendy: Christine and I were there from the CAG, and there were also representatives from the offices of Assemblymember Grace Lee and State Senator Kavanaugh. Councilmember Marte

was there at the very beginning but had to leave due to the ICE raid happening on Canal Street. One of our biggest takeaways is that we need to talk to Luc or someone else from Parks about what is and isn't possible. During the day the park is often pretty empty because of the heat issue, and it fills up in the later afternoon and evening. We have many questions. The Fireboat House provides some shade; is that a reason to keep it around until the trees mature? Also, where can fast-growing grasses be put? Where are the areas where FEMA- or Parks-related rules apply and they cannot be planted? Could the solar panels throughout the park have an additional shade structure or something growing on them to provide shade? Assemblymember Lee's office has capital funding, and we can make a proposal related to shade and other things that are missing in the park (such as lifesaving rings, police call boxes). We can also ask Stuy Cove Park about their experience with their Councilmember giving them \$50,000.

Paula: Thank you, Wendy. So the main takeaway is that there are several potential shade solutions, but they need to be vetted with Parks for their plausibility. As a next step, I propose that we have a dedicated meeting on this topic with Parks before the next CAG meeting.

Wendy: There's a shared document that we have already started about potential shade solutions... (she says more, but her connection is bad and she's inaudible).

Paula: Does anyone have any questions about the proposed next step? If not, then I will reach out to the CAG and Luc to set up a meeting.
