| 1 | 07/12/24–07/27/24 | 6:00 am to 11:59 pm | East River Park: South of the Williamsburg Bridge | Ongoing fill operations, floodwall installation, esplanade reconstruction along waterfront and park drainage work. Construction of Ballfields 1 and 2, including lighting foundation installation, installation of Park features. Amphitheatre foundation, bike path construction and work on new Delancey Street Bridge adjacent to M&O area. Weekend work and extended weekday working hours anticipated. |
| 2 | 07/12/24–07/27/24 | 7:00 am to 5:00 pm | East River Park: North of the Williamsburg Bridge to E. 10 th Street | Entrances at E. Houston Street, E. 6th St. Bridge and E. 10th St. Bridge are open. Greenway between E. 12th to E. 20th St open. Utility work, floodwall installation, installation of rigid inclusions, excavation of soil removal in Ballfields 3, 4, and 5, see Advisory . |
| 3 | 07/12/24–07/27/24 | 6:00 am to 11:59 pm | East River Park: E. Houston St. Overpass | Ongoing retaining wall construction activities, including excavation and pile installation. Pedestrians use the Baruch Pl. crosswalk to access the north ramp into the park, see Advisory . |
| 4 | 07/12/24–07/27/24 | 7:00 am to 3:30 pm | Montgomery Street / South Street area and Various Locations: | Ongoing micropile installation, fence installation, ConEd work and jet grouting. Montgomery St. parking lot sidewalk closed for floodwall construction, see Advisory . Ongoing floodwall operations at Montgomery St. and South St., see Advisory . |
| 5 | 07/12/24–07/27/24 | 7:00 am to 6:00 pm | East River Park Greenway & FDR Dr. between Montgomery St. & Jackson St.: | Ongoing jet grouting for floodwall and Con Edison utility work. Abatement of Steam Line and test pile work. FDR Dr. NB Montgomery St. on-ramp shifted onto East River Greenway, see Advisory . |
| 6 | 07/12/24–07/27/24 | 6:00 am to 5:00 pm | Corlears Hook Park Flagpole Area and Pedestrian Bridge: | For public access to ferry use the temporary bridge at Corlears Hook, see Advisory. Ongoing site excavation, utility work, bridge abutment, anti-graffiti work, installation of park features and wingwall installation for new Corlears Hook Bridge. |
| 7 | 07/12/24–07/27/24 07/20/24 | 7:00 am to 5:00 pm 10:00 pm to 7:00 am | FDR Drive Service Road between Grand Street and Delancey Street Pedestrian Bridge: | Utility, electric conduit, curb and sidewalk work, test pits, fence relocation and pier construction. Overnight FDR Drive Service Road SB Closure for new Delancey St. Bridge work, see Advisory . |
| 8 | 07/12/24–07/27/24 07/15/24–07/20/24 | 7:00 am to 5:00 pm 10:00 pm to 7:00 am | E. 10 th St. between FDR Drive and Ave D: FDR Drive NB / SB from Jackson St. to E. 10 th St. | Ongoing utility work, pile installation, and deep sewer work, see Advisory . Daytime road & sidewalk closures, see Advisory . Single lane closure for New Delancey St. Bridge work. |

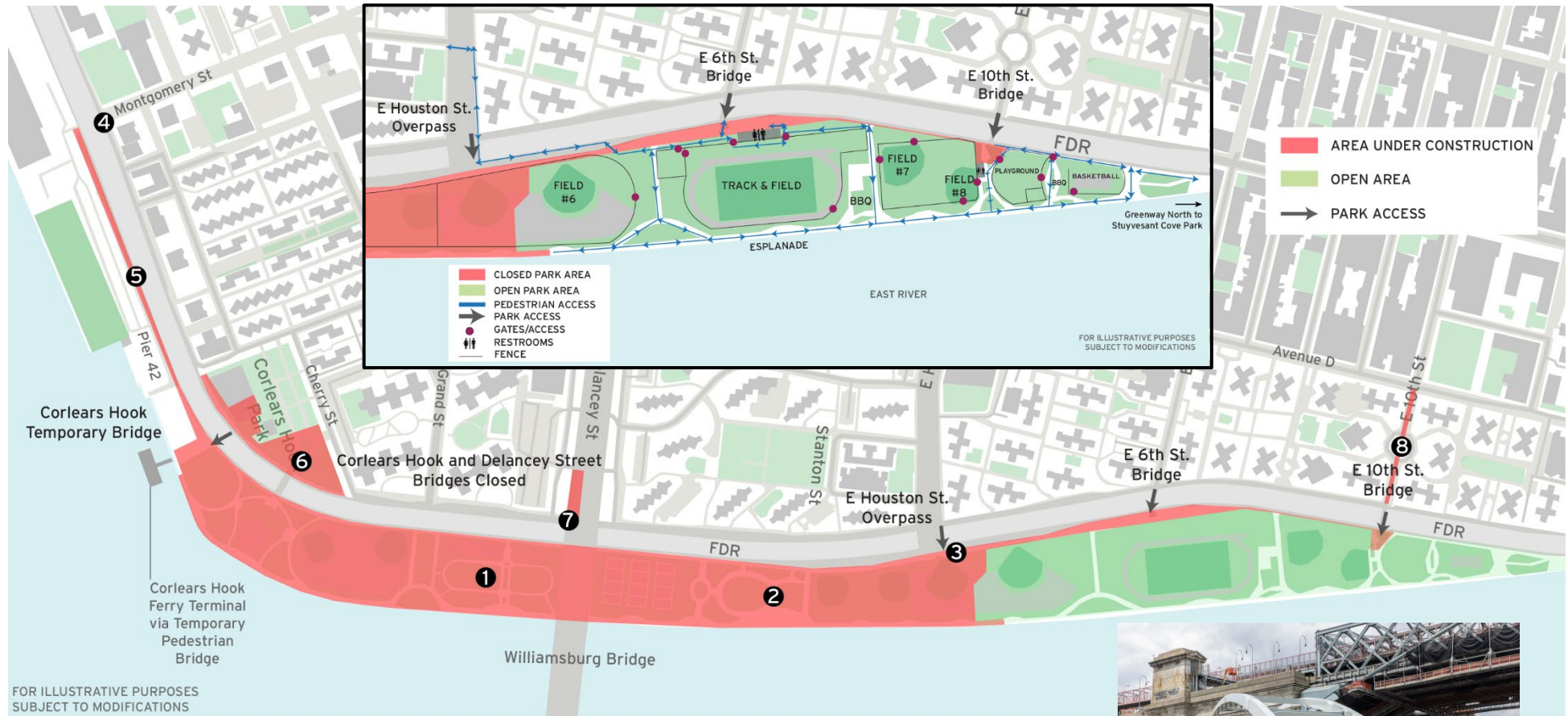
