Sidewalk at Delancey St. and FDR Dr. service road closed for construction activities, see <a href="#">Advisory</a> .

Houston St. north ramp pedestrian access shift to the FDR Dr. E. Houston St. on-ramp, see <a href="#">Advisory</a> .

7	09/30/23–10/14/23	7:00 am to 6:00 pm	<b>East River Park Greenway &amp; FDR Dr. between Montgomery St. &amp; Jackson St.</b>	Ongoing sheet pile installation and Con Edison utility abatement work. FDR Dr. NB Montgomery St. on-ramp shifted onto East River Greenway, see <a href="#">Advisory</a> . Possible overnight work with FDR lane closure.
8	09/30/23–10/14/23	9:00 am to 2:00 pm 7:00 am to 3:30 pm	<b>Montgomery Street / South Street area and Various Locations</b>	Ongoing Con Edison work, test pits and utility work. <b>Weekend work anticipated.</b> Montgomery St. parking lot sidewalk closed for floodwall construction, see <a href="#">Advisory</a> .

The contractor may extend work hours and/or occur on weekends when necessary, as approval by NYC DDC.

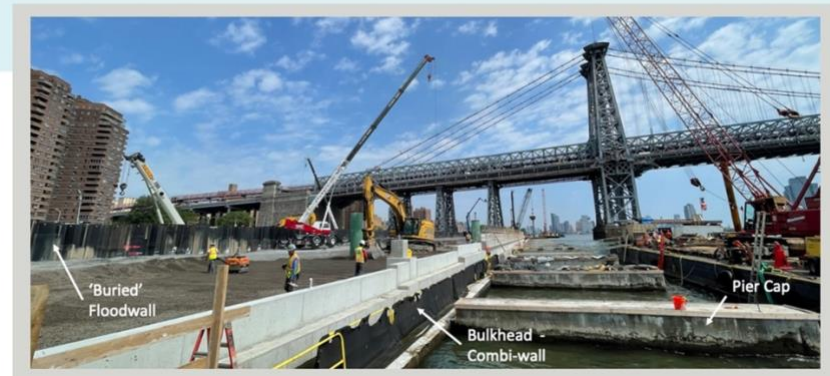
