2	09/25/23-10/06/23	7:00 am to 3:30 pm	E 18 th Street @ the southbound entrance Ramp FDR Dr. & Ave C	Streetlights and traffic signals installation
3	09/25/23-10/06/23	7:00 am to 3:30 pm	Murphy Brothers Playground	Park is closed for construction activities. Drainage replacement and sidewalk construction ongoing
4	09/25/23-10/06/23	7:00 am to 3:30 pm	Southbound shoulder between E 15 th Street and E 16 th Street	Pile installation work ongoing Con Edison work – Utility


