3	12/26/23-1/05/23	7:00 am to 3:30 pm	Murphy Brothers Playground	The park is closed for construction activities. Floodwall construction continues
4	12/26/23-1/05/23	7:00 am to 3:30 pm	Southbound shoulder between E 16 th Street and Murphy Brother	Floodwall construction continues.
5	12/26/23-1/05/23	7:00 am to 3:30 pm	Southbound shoulder between E 15 th Street and E 16 th Street	Pile installation and floodwall construction ongoing Con Edison work – Utility

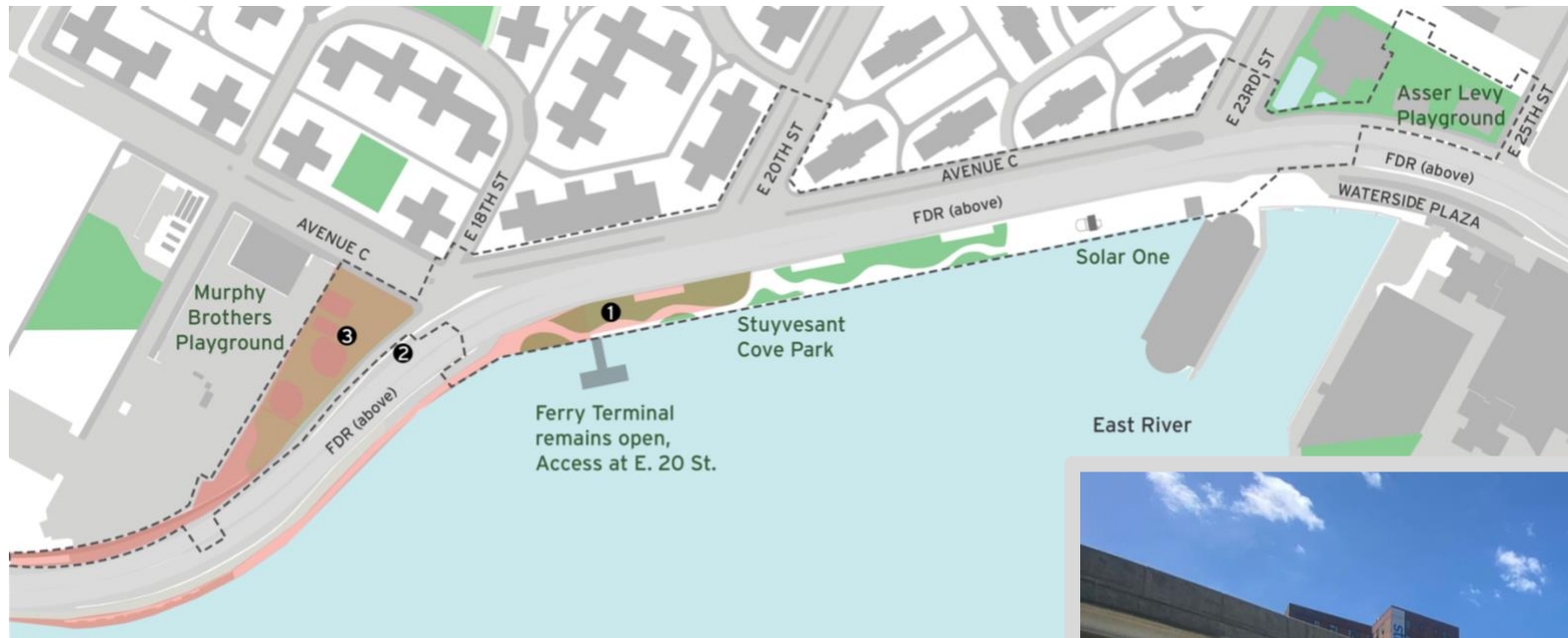
