3	1/02/24-1/12/24	7:00 am to 3:30 pm	Murphy Brothers Playground	The park is closed for construction activities. Floodwall construction continues
4	1/02/24-1/12/24	7:00 am to 3:30 pm	Southbound shoulder between E 16 th Street and Murphy Brother	Floodwall construction continues.
5	1/02/24-1/12/24	7:00 am to 3:30 pm	Southbound shoulder between E 15 th Street and E 16 th Street	Pile installation and floodwall construction are ongoing. Con Edison work – Utility

Utility work by Con Edison, ECS, etc. may extend work hours and/or occur on weekends to facilitate utility relocations, maintenance work or inspection services.

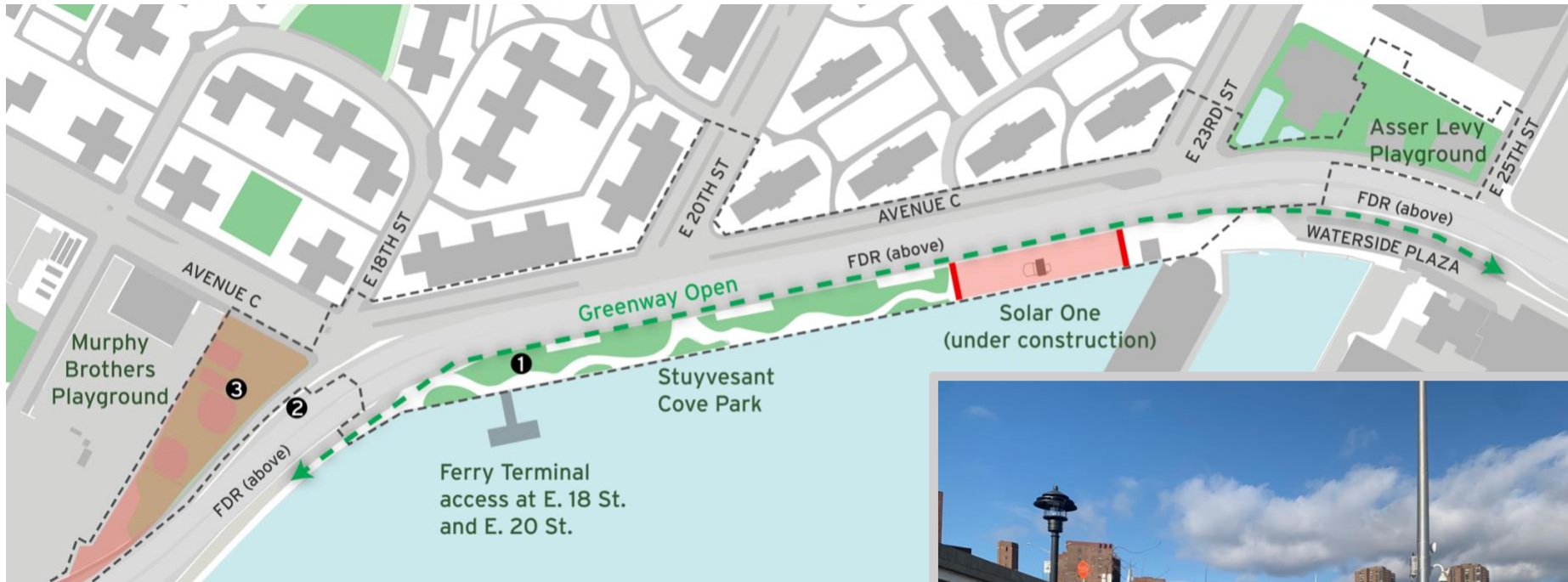

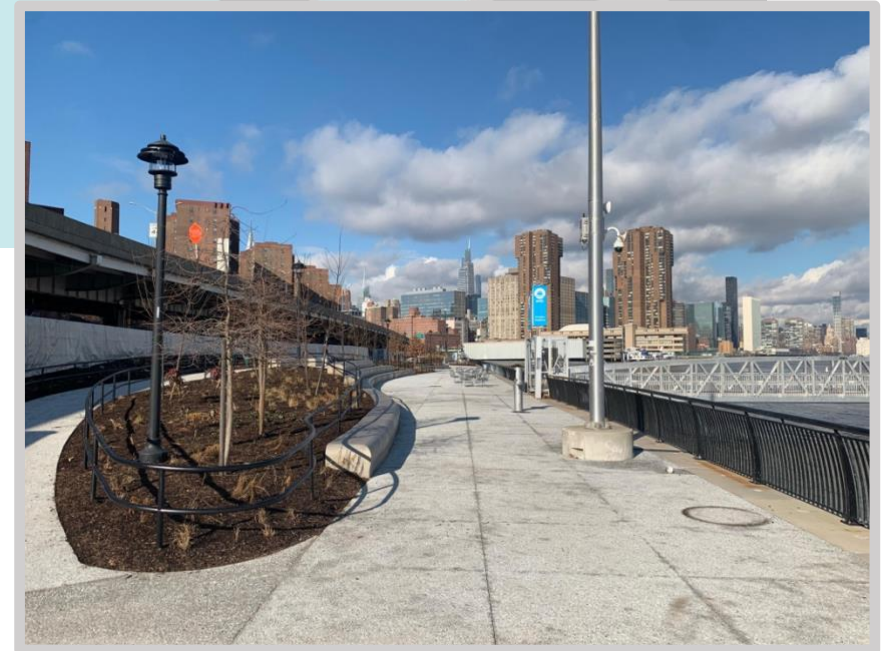
