2	1/15/24-1/26/24	7:00 am to 3:30 pm	Southeast corner of E 23 rd Street & Ave C	DOT fiber optic cable installation
3	1/15/24-1/26/24	7:00 am to 3:30 pm	Murphy Brothers Playground	The park is closed for construction activities. Floodwall construction continues
4	1/15/24-1/26/24	7:00 am to 3:30 pm	Southbound shoulder between E 16 th Street and Murphy Brother	Floodwall construction continues.
5	1/15/24-1/26/24	7:00 am to 3:30 pm	Southbound shoulder between E 15 th Street and E 16 th Street	Pile installation and floodwall construction are ongoing. Con Edison work – Utility

REMINDERS: Greenway between E. 20th to E. 12th St has been reopened to the community.

Utility work by Con Edison, ECS, etc. may extend work hours and/or occur on weekends to facilitate utility relocations, maintenance work or inspection services.

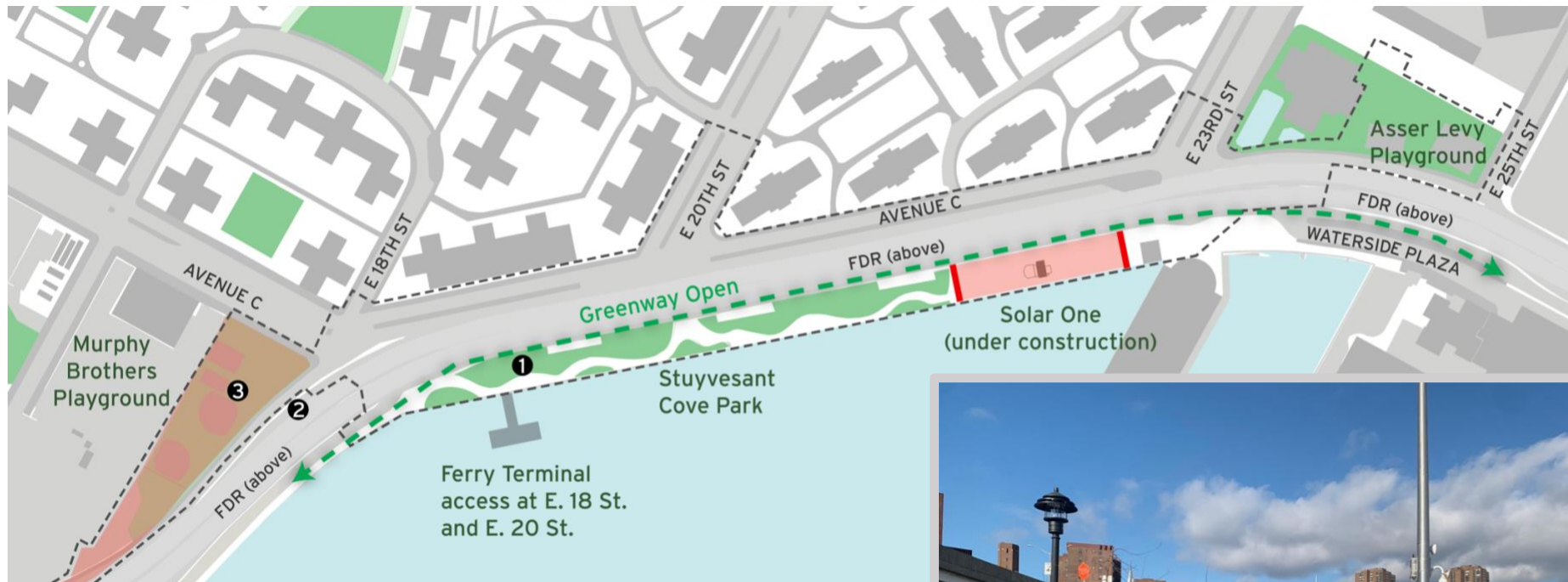

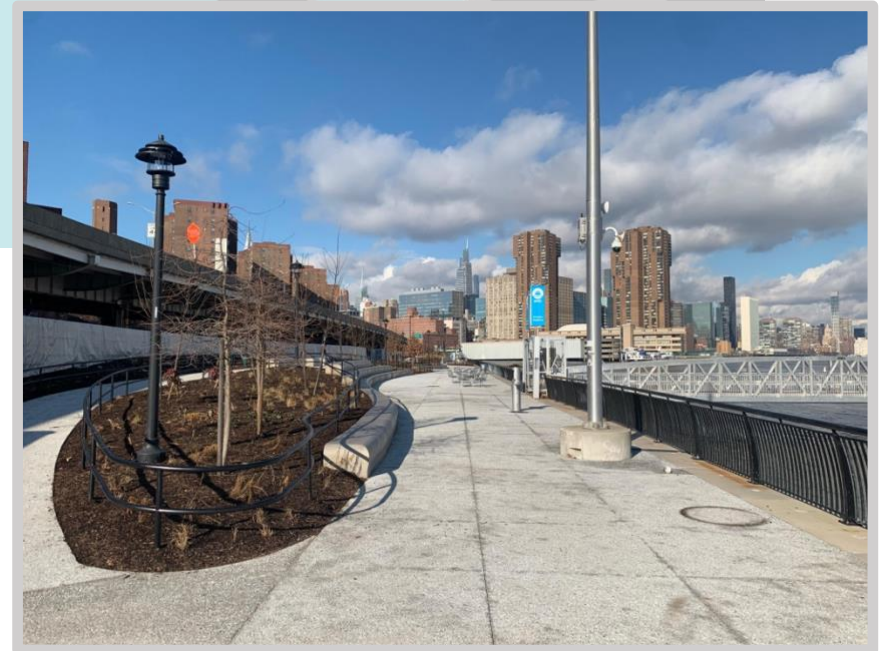
