2	3/04/24-3/15/24	7:00 am to 3:30 pm	Murphy Brothers Playground	The park is closed for construction activities. Preparing for park reconstruction
3	3/04/24-3/15/24	7:00 am to 3:30 pm	Southbound shoulder between E 16 <sup>th</sup> Street and Murphy Brother	Final restoration & Barriers installation along the FDR ramp.
4	3/04/24-3/15/24	7:00 am to 3:30 pm	Southbound shoulder between E 15 <sup>th</sup> Street and E 16 <sup>th</sup> Street	Floodwall construction continues.

**REMINDERS: Greenway between E. 20th to E. 12th St has been reopened to the community.**




