3	4/01/24-4/12/24	7:00 am to 3:30 pm	Murphy Brothers Playground	The park is closed for construction activities. Park reconstruction continues.
4	4/01/24-4/12/24	7:00 am to 3:30 pm	Southbound shoulder between E 15 <sup>th</sup> Street and E 17 <sup>th</sup> Street	Floodwall construction and Barriers installation continues
5	4/01/24-4/12/24	7:00 am to 3:30 pm	Asser Levy Pool	Pool repair begins

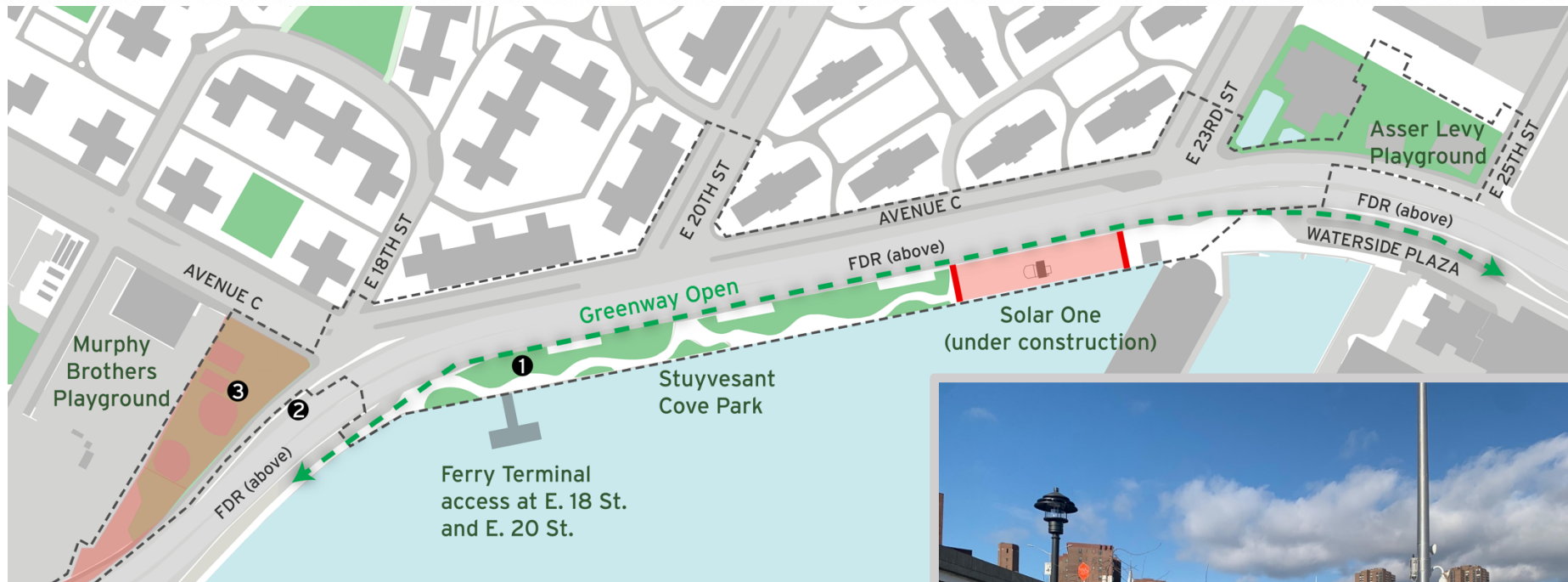
