1	6/24/24-7/05/24	7:00 am to 3:30 pm	Stuyvesant Cove Park North/South from E 23 rd Street to E 18 th Street	No access to Stuyvesant Cove Park from E 23 rd Street entrance. Punch list ongoing
2	6/24/24-7/05/24	7:00 am to 3:30 pm	Murphy Brothers Playground	The park is closed for construction activities. Park reconstruction continues. Curb, sidewalk, electrical, and plumbing work ongoing.
3	6/24/24-7/05/24	7:00 am to 3:30 pm	Southbound shoulder between E 15 th Street and E 17 th Street	Curb, Sidewalk & Barrier installation in progress Final restoration begins.
4	6/24/24-7/05/24	7:00 am to 3:30 pm	Asser Levy Pool	Pool Repair and fence installation are in progress

REMINDERS: Greenway between E. 23rd to E. 12th St has been reopened to the community.

Utility work by Con Edison, ECS, etc. may extend work hours and/or occur on weekends to facilitate utility relocations, maintenance work or inspection services.


