| 1 | 7/22/24-8/02/24 | 7:00 am to 3:30 pm | Stuyvesant Cove Park North/South from E 23 rd Street to E 18 th Street | No access to Stuyvesant Cove Park from E 23 rd Street entrance. Punch list ongoing. |
| 2 | 7/22/24-8/02/24 | 7:00 am to 3:30 pm | Murphy Brothers Playground | The park is closed for construction activities. Park reconstruction continues. Curb, sidewalk, electrical, and plumbing work ongoing. |
| 3 | 7/22/24-8/02/24 | 7:00 am to 3:30 pm | Southbound shoulder between E 15 th Street and E 17 th Street | Curb, Sidewalk & Barrier installation in progress. Final restoration in progress. |
| 4 | 7/22/24-8/02/24 | 7:00 am to 3:30 pm | Asser Levy Pool | Pool Repair in progress. |

REMINDERS: Greenway between E. 23rd to E. 12th St has been reopened to the community.

Utility work by Con Edison, ECS, etc. may extend work hours and/or occur on weekends to facilitate utility relocations, maintenance work or inspection services.
