2	12/11/23-12/22/23	7:00 am to 3:30 pm	Southwest corner of E 23 rd Street & Ave C	Traffic signal installation
3	12/11/23-12/22/23	7:00 am to 3:30 pm	Murphy Brothers Playground	The park is closed for construction activities. Preparing for floodwall construction
4	12/11/23-12/22/23	7:00 am to 3:30 pm	Southbound shoulder between E 16 th Street and Murphy Brother	Floodwall construction continues. Con Edison work – Utility
5	12/11/23-12/22/23	7:00 am to 3:30 pm	Southbound shoulder between E 15 th Street and E 16 th Street	Pile installation and floodwall construction ongoing Floodwall construction Con Edison work – Utility


