2	12/18/23-12/29/23	7:00 am to 3:30 pm	Southwest corner of E 23 rd Street & Ave C	Traffic signal installation
3	12/18/23-12/29/23	7:00 am to 3:30 pm	Murphy Brothers Playground	The park is closed for construction activities. Floodwall construction continues
4	12/18/23-12/29/23	7:00 am to 3:30 pm	Southbound shoulder between E 16 th Street and Murphy Brother	Floodwall construction continues.
5	12/18/23-12/29/23	7:00 am to 3:30 pm	Southbound shoulder between E 15 th Street and E 16 th Street	Pile installation and floodwall construction ongoing Con Edison work – Utility

Utility work by Con Edison, ECS, etc. may extend work hours and/or occur on weekends to facilitate utility relocations, maintenance work or inspection services.

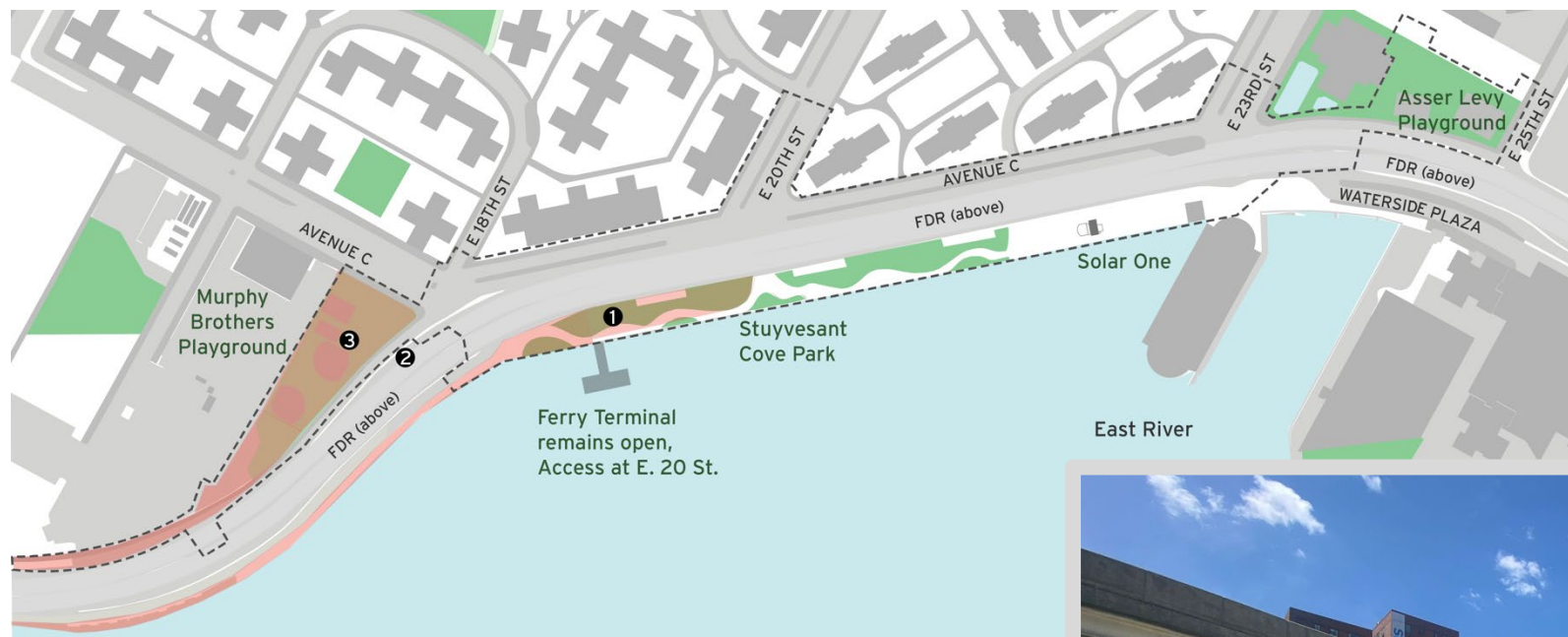
