3	3/11/24-3/22/24	7:00 am to 3:30 pm	Murphy Brothers Playground	The park is closed for construction activities. Preparing for park reconstruction
4	3/11/24-3/22/24	7:00 am to 3:30 pm	Southbound shoulder between E 16 th Street and Murphy Brother	Final restoration & Barriers installation along the FDR ramp.
5	3/11/24-3/22/24	7:00 am to 3:30 pm	Southbound shoulder between E 15 th Street and E 16 th Street	Floodwall construction continues.

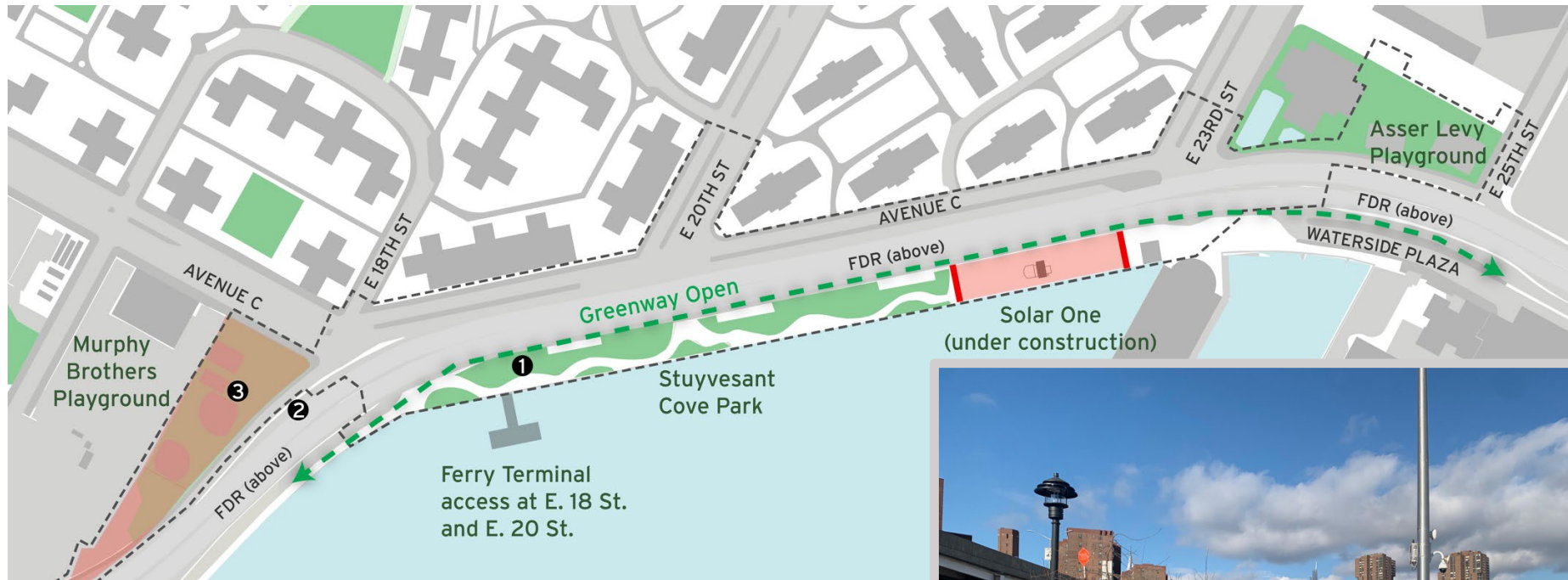
