This application shall not be used for modifications of any provision of the New York City Building Code, including design requirements for fire alarm systems.
- **B.** Submit the completed application electronically through **FDNY Business.** This application must be accompanied by all necessary supporting documents, including as applicable design and installation documents.
- C. A non-refundable application fee of \$200.00 is required at the time of filing, in accordance with FC A04(5). Payments shall be made electronically at NYC's CityPay. If determined during the plan examination that this application is considered a Complex Technical Analysis, you will be required to pay a "Complex Technical Analysis Fee."
- **D.** All revisions must be accompanied by a detailed cover/transmittal letter explaining the revised sections.
- **E.** Complete all 18 sections of this application. Do not leave any sections blank. If a particular section is not applicable, mark the section "N/A". Sections 9, 10, 11, 14, 15 and 16 may require that additional documentation be filed with the application.
