<sup>3</sup> The NYS GFP metric includes all spend for items that were either grown, processed, manufactured, or distributed by business enterprises located within New York State. In comparison, the Good Food Purchasing Program local definition also takes ownership structure into account, only including spend for items where the grower, processor, or manufacturer is family or cooperatively owned, and the spend is weighted based on different points in the supply chain.
