**Purpose.** The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services, including changes to these policies, and informs HUD, families served by the PHA, and members of the public of the PHA's mission, goals and objectives for serving the needs of low- income, very low- income, and extremely low- income families

**Applicability.** The Form HUD-50075-HP is to be completed annually by **High Performing PHAs**. PHAs that meet the definition of a Standard PHA, Troubled PHA, HCV-Only PHA, Small PHA, or Qualified PHA do not need to submit this form.

**Definitions.**

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers and was designated as a high performer on both the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, and that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceed 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceed 550, and that was designated as a standard performer in the most recent PHAS or SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined and is not PHAS or SEMAP troubled.

These funds support HPD's rental assistance for households with a non-elderly family member age 18-61 with a disability, and who is transitioning out of institutional or other segregated settings, is at serious risk of institutionalization, is homeless or is at risk of becoming homeless.</b></p> <p><b><u>Family Self-Sufficiency</u></b>  <b>HPD has received a total of \$2.1 million in grant funding for its Family Self-Sufficiency (FSS) program for the 2023 calendar year for salaries of program staff. HPD's FSS staff work directly with FSS program participants at they progress towards reaching their employment and educational goals with the goal of increasing their economic independence and self-sufficiency and financial empowerment.</b></p> <p><b>In addition, HPD adopted new subsidy standards, effective 8/15/2022, which constitutes a significant amendment. HPD selects developments that will supply housing to low-income households that include the following populations: seniors, disabled, veterans, youth aging out of foster care, families reunifying with children in foster care, victims of domestic violence, and homeless households. HPD will award approximately 500 to 600 PBV units this year citywide, across all five boroughs of New York City.</b></p>

<p><b>B.3</b></p>	<p><b>Progress Report.</b></p> <p>Provide a description of the PHA’s progress in meeting its Mission and Goals described in the PHA 5-Year Plan.</p> <p>HPD has continued to invest in creating and preserving affordable housing, supportive housing, and related services for vulnerable New Yorkers, including preservation of affordable housing through project-based vouchers and conversions of property through the Rental Assistance Demonstration projects. Through the COVID-19 pandemic HPD had invested resources and staff to ensuring remote operations are accessible and allowing rental subsidy administration to continue uninterrupted. As HUD updated its pandemic related waivers, HPD informed its participants of its return to normal operations and continues to offer online and in-person opportunities for participants to engage. This year, HPD also launched a mobility counseling initiative (Neighborhood Choice) to assist Emergency Housing Voucher applicants to move to neighborhoods with low poverty, low crime, and better resourced public schools. HPD is also focused on technology initiatives that will expand opportunities for both participants and owners to use electronic access to comply with program requirements. HPD was awarded vouchers and funding through the HUD Community Choice Mobility Demonstration Notice of Funding Opportunity. HPD was awarded funding to serve 1,950 program participants over six years, this will bring an associated \$4 million. HPD is one of nine project sites selected across the country. This award augments Housing Choice: HPD’s mobility counseling program that started as a pilot in 2018 and was expanded through Enterprise funding in 2021. The Community Choice Demonstration allows for a fully implemented mobility counseling program that will last through 2027.</p> <p>HPD launched the Community Choice Demonstration (CCD) in October. CCD will assist 1,950 program participants over six years and HPD has selected approximately 40 households to participate in the Demonstration to date. CCD allows for a fully implemented mobility counseling program that will last through 2027. The program is designed to address the barriers that prevent participants from exercising their choice in accessing units in competitive, amenity rich neighborhoods. Key features of Housing Choice include tenant support, owner support, and exception payment standards through three phases of participation (pre-move, housing search, and post-move). This includes workshops, financial counseling, transportation costs, security deposits, owner bonuses, brokers’ fees, moving costs, and case management. Housing Choice uses exception payment standards in ZIP Codes with low rates of crime, low rates of poverty, and/or more well-resourced schools. Many of these program features have been included in the Demonstration.</p> <p>HPD is collaborating with the New York City Housing Authority, the Continuum of Care and the NYC Department of Social Services and other New York City agencies and partners to administer 7,800 Emergency Housing Vouchers. To date 3,500 households have successfully used their vouchers and all vouchers have been issued by both agencies. HPD is providing housing search assistance through broker’s fees, a one-time payment to the owner and housing navigation support through either City agencies or contracted community-based organizations that offer housing navigator support. This year, HPD introduced Unit Hold Fees, increased payment standards from 108% of FMR to 110% of FMR and increased its subsidy standards to enable successful use of EHV.</p>

**C.1 Resident Advisory Board (RAB) comments.** If the RAB had comments on the annual plan, mark “yes,” submit the comments as an attachment to the Plan and describe the analysis of the comments and the PHA’s decision made on these recommendations. ([24 CFR §903.13\(c\)](#), [24 CFR §903.19](#))

Form HUD-50077-ST-HCV-HP, *PHA Certifications of Compliance with PHA Plan, Civil Rights, and Related Laws and Regulations Including PHA Plan Elements that Have Changed* must be submitted by the PHA as an electronic attachment to the PHA Plan. This includes all certifications relating to Civil Rights and related regulations. A PHA will be considered in compliance with the certification requirement to affirmatively further fair housing if the PHA fulfills the requirements of §§ 903.7(o)(1) and 903.15(d) and: (i) examines its programs or proposed programs; (ii) identifies any fair housing issues and contributing factors within those programs, in accordance with 24 CFR 5.154; or 24 CFR 5.160(a)(3) as applicable (iii) specifies actions and strategies designed to address contributing factors, related fair housing issues, and goals in the applicable Assessment of Fair Housing consistent with 24 CFR 5.154 in a reasonable manner in view of the resources available; (iv) works with jurisdictions to implement any of the jurisdiction's initiatives to affirmatively further fair housing that require the PHA's involvement; (v) operates programs in a manner consistent with any applicable consolidated plan under 24 CFR part 91, and with any order or agreement, to comply with the authorities specified in paragraph (o)(1) of this section; (vi) complies with any contribution or consultation requirement with respect to any applicable AFH, in accordance with 24 CFR 5.150 through 5.180; (vii) maintains records reflecting these analyses, actions, and the results of these actions; and (viii) takes steps acceptable to HUD to remedy known fair housing or civil rights violations. impediments to fair housing choice within those programs; addresses those impediments in a reasonable fashion in view of the resources available; works with the local jurisdiction to implement any of the jurisdiction’s initiatives to affirmatively further fair housing; and assures that the annual plan is consistent with any applicable Consolidated Plan for its jurisdiction. ([24 CFR §903.7\(o\)](#)).

Until such time as the PHA is required to submit an AFH, the PHA will not have to complete section D., nevertheless, the PHA will address its obligation to affirmatively further fair housing by fulfilling the requirements at 24 CFR 903.7(o)(3) enacted prior to August 17, 2015, which means that it examines its own programs or proposed programs; identifies any impediments to fair housing choice within those programs; addresses those impediments in a reasonable fashion in view of the resources available; works with local jurisdictions to implement any of the jurisdiction’s initiatives to affirmatively further fair housing that require the PHA’s involvement; and maintain records reflecting these analyses and actions. Furthermore, under Section 5A(d)(15) of the U.S. Housing Act of 1937, as amended, a PHA must submit a civil rights certification with its Annual PHA Plan, which is described at 24 CFR 903.7(o)(1) except for qualified PHAs who submit the Form HUD-50077-CR as a standalone document.
