Purpose. The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services, including changes to these policies, and informs HUD, families served by the PHA, and members of the public of the PHA's mission, goals and objectives for serving the needs of low- income, very low- income, and extremely low- income families.

Applicability. The Form HUD-50075-ST is to be completed annually by **STANDARD PHAs or TROUBLED PHAs**. PHAs that meet the definition of a High Performer PHA, Small PHA, HCV-Only PHA or Qualified PHA do not need to submit this form.

Definitions.

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers, and was designated as a high performer on both the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments if administering both programs, or PHAS if only administering public housing.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceed 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceed 550, and that was designated as a standard performer in the most recent PHAS or SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined and is not PHAS or SEMAP troubled.

HPD’s FSS staff work directly with FSS program participants as they progress towards reaching their employment and educational goals with the goal of increasing their economic independence and self-sufficiency and financial empowerment. • HPD has received \$3.1 million in grant funding and \$117,500 in Special Fee funding for the Stability Voucher program, effective 10/1/2023. HPD selects developments that will supply housing to low-income households that include the following populations: seniors, disabled, veterans, youth aging out of foster care,</p>

	families reunifying with children in foster care, victims of domestic violence, and homeless households. HPD anticipates awarding approximately 700 to 1,000 PBV units this year citywide, across all five boroughs of New York City.
B.3	<p>Progress Report.</p> <p>Provide a description of the PHA’s progress in meeting its Mission and Goals described in the PHA 5-Year and Annual Plan.</p> <p>HPD has continued to invest in creating and preserving affordable housing, supportive housing, and related services for vulnerable New Yorkers, including preservation of affordable housing through project-based vouchers and conversions of property through the Rental Assistance Demonstration projects.</p> <p>HPD is continuing to collaborate with the New York City Housing Agency (NYCHA), the New York City Continuum of Care, the New York City Department of Social Services, and other New York City agencies and partners to administer 7,800 Emergency Housing Vouchers (EHVs). The EHV Program helps families and individuals who are experiencing homelessness; at-risk of homelessness; fleeing or attempting to flee domestic violence, dating violence, sexual assault, stalking, or human trafficking; or recently homeless and at high risk of housing instability to find housing by subsidizing a portion of rent based on their income. HPD is providing housing search assistance through broker’s fees, a one-time payment to the owner and housing navigation support through either City agencies or contracted community-based organizations that offer housing navigator support. To date, all EHV vouchers have been successfully utilized.</p> <p>HPD has started implementing a range of program streamlining provisions. These changes include updating its application and property owner registration processes some of which were introduced through the Housing Opportunity through Modernization Act (HOTMA). These steps will further improve the effectiveness, efficiency, and experience of our Housing Choice Voucher Section 8 Program.</p>

A PHA will be considered in compliance with the certification requirement to affirmatively further fair housing if the PHA fulfills the requirements of §§ 903.7(o)(1) and 903.15(d) and: (i) examines its programs or proposed programs; (ii) identifies any fair housing issues and contributing factors within those programs, in accordance with 24 CFR 5.154 or 24 CFR 5.160(a)(3) as applicable; (iii) specifies actions and strategies designed to address contributing factors, related fair housing issues, and goals in the applicable Assessment of Fair Housing consistent with 24 CFR 5.154 in a reasonable manner in view of the resources available; (iv) works with jurisdictions to implement any of the jurisdiction’s initiatives to affirmatively further fair housing that require the PHA’s involvement; (v) operates programs in a manner consistent with any applicable consolidated plan under 24 CFR part 91, and with any order or agreement, to comply with the authorities specified in paragraph (o)(1) of this section; (vi) complies with any contribution or consultation requirement with respect to any applicable AFH, in accordance with 24 CFR 5.150 through 5.180; (vii) maintains records reflecting these analyses, actions, and the results of these actions; and (viii) takes steps acceptable to HUD to remedy known fair housing or civil rights violations. impediments to fair housing choice within those programs; addresses those impediments in a reasonable fashion in view of the resources available; works with the local jurisdiction to implement any of the jurisdiction’s initiatives to affirmatively further fair housing; and assures that the annual plan is consistent with any applicable Consolidated Plan for its jurisdiction. (24 CFR §903.7(o)).

C.4 Challenged Elements.
