XRF testing indicated there is no lead-based paint as defined by Local Law 1 of 2004 on window and door friction surfaces, but there were other surfaces that tested positive or there were untested surfaces in the unit. However, there was no peeling paint on those surfaces that tested positive or on untested surfaces at the time of turnover AND floors were smooth and cleanable at the time of turnover.

\_ c. XRF testing indicated one or more inconclusive results. The paint chip sampling performed on those inconclusive surfaces combined with the XRF results has confirmed that there is no lead-based paint as defined by Local Law 1 of 2004 in the unit.

- A copy of the paint chip sampling report prepared by an EPA-certified Inspector or Risk Assessor;

- A notarized Affidavit by the Inspector or Risk Assessor who conducted the XRF testing and paint chip sampling (Affidavit sample enclosed with this Notice of Violation); and
- A copy of the State-certified laboratory analysis of the paint chip sample.
