ADDENDUM #4

The Department of Housing Preservation and Development is issuing **Addendum #4** to the Request for Qualifications for Qualified Marketing Agents ("RFQ" hereafter).

I. QUESTIONS AND ANSWERS

a. RFQ Questions by email

The following Questions were presented to HPD via email between 1/6/2021 and 1/18/2021. The Answers to those Questions are provided below for clarification and information purposes only, and do not change the terms and conditions as contained in the issued RFQ:

Question #1: I am trying to download the forms for the RFQ but I don't seem to be able to. When I press "submit" nothing happens. It asks to check the "I am not a robot" box, but that box doesn't appear. Please send me the package or a new link. And please confirm if I am registered.

<u>Answer #1</u>: HPD Tech has tested the RFQ download functionality and confirmed that it is functional. If you continue to experience issues downloading the forms, try refreshing the website or downloading from the Google Chrome web browser.

Question #2: I attended the Pre-Submission meeting on 10/7 and actually announced my name when asked at the start, and I am not reflected on the attendee list.

Answer #2: This was an error of omission and the following company and representative has been added to the attendee list:

Question #3: How can I register for the February 3rd Pre-Submission Conference?

Answer #3: Per Section II. A. ("Application", page 3) of the RFQ, "All interested parties that have registered to download this RFQ on HPD's website (https://www1.nyc.gov/site/hpd/services-and-information/rfps-rfqs-rfeis.page) will be invited to both pre-submission conferences."

<u>Question #4</u>: Regarding the training sessions, are they a few hours or full day trainings? <u>Answer #4</u>: The HPD Marketing Training is roughly eight hours split across two consecutive days. The next scheduled training is January 27-28 from 11:30 – 3:30. To request attendance, please send an email to <u>NYCHPD Marketing@hpd.nyc.gov</u>.

Question #5: Will marketing agents applying to this RFQ be approved on a rolling basis or does everyone have to wait until after the March deadline for submissions?

Answer #5: Applications to this RFQ will be reviewed on a rolling basis and according to Agency capacity. Applicants approved to appear on the initial Qualified List will be informed at the time of the list's publication, expected some months after the initial deadline. If the Agency has determined that an Applicant is not qualified, it shall state the reasons upon which such determination is based.

Question #6: Good morning and thank you for the email. I was going over the questions, but couldn't locate where the answers can be found. I download the handbook and noticed that the answers are not there. Where can I find the answers on the hpd site?
