Purpose. The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services, and informs HUD, families served by the PHA, and members of the public of the PHA's mission, goals and objectives for serving the needs of low- income, very low- income, and extremely low- income families

Applicability. Form HUD-50075-HP is to be completed annually by **High Performing PHAs**. PHAs that meet the definition of a Standard PHA, Troubled PHA, HCV-Only PHA, Small PHA, or Qualified PHA do not need to submit this form.

Definitions.

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers, and was designated as a high performer on both of the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, or at risk of being designated as troubled, and that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceeds 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment, and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceeds 550, and that was designated as a standard performer in the most recent PHAS or SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined, and is not PHAS or SEMAP troubled.

Financial resources for these programs are listed below:</p> <p><u>Emergency Housing Vouchers (EHV)</u> HPD’s EHV award consists of \$27.9 million in Housing Assistance Payments, \$820,000 in preliminary fees, \$7.2 million in service fees, and \$2.8 million in administrative fees, effective 7/1/2021. These funds support rental assistance and additional housing search assistance for households that are homeless, at risk of homelessness, eligible for Violence Against Women Act (VAWA) protections, and who are at high risk of housing instability.</p> <p><u>Mobility Demonstration Program</u> HPD has received a total of \$4 million in funding for its mobility-related services, including \$191,000 in start-up funds and \$3.8 million in comprehensive and selected mobility-related services to families with children. These services are provided to participating families to address barriers to accessing low-poverty neighborhoods with high-performing schools and other strong community resources. In addition, HPD will receive a total of \$1.5 million in anticipated HAP expenditures over the six-year grant period, with \$238,000 and \$248,000 for an anticipated 74 families to lease-up over the course of the Demonstration.</p> <p><u>Family Self-Sufficiency</u> HPD has received a total of \$2.1 million in grant funding for its Family Self-Sufficiency (FSS) program, for the 2022 calendar year. This funds the salaries of program staff who work directly with FSS program participants in attaining employment and educational goals to increase their economic independence and self-sufficiency and financial empowerment.</p>

HPD selects developments that will supply housing to low-income households that include the following populations: seniors, disabled, veterans, youth aging out of foster care, families reunifying with children in foster care, victims of domestic violence, and homeless households. HPD will award between 900-1,100 PBV units this year across all 5 boroughs of New York City.</p>

<p>B.3</p>	<p>Progress Report.</p> <p>Provide a description of the PHA’s progress in meeting its Mission and Goals described in the PHA 5-Year Plan.</p> <p>HPD has continued to invest in creating and preserving affordable housing, supportive housing, and related services for vulnerable New Yorkers, including preservation of affordable housing through project-based vouchers and conversions of property through the Rental Assistance Demonstration projects. Through the COVID-19 pandemic HPD has invested resources and staff to ensuring remote operations are accessible and allowing rental subsidy administration to continue uninterrupted. HPD has invested in services and staffing in both the Family Self-Sufficiency program to facilitate economic independence for participants, and in the eviction prevention services offered through the Homelessness Prevention Program. <i>Housing Choice</i>: HPD’s Mobility Counseling Program initiated its expanded pilot program to provide special assistance to Section 8 voucher holders to move to neighborhoods with low poverty, low crime, and better resourced public schools. HPD has also continued to improve the effectiveness, efficiency, and experience of services provided through the Section 8 program, including expanding opportunities for both participants and owners to use electronic access to comply with program requirements.</p> <p>HPD was awarded vouchers and funding through the HUD Community Choice Mobility Demonstration Notice of Funding Opportunity. HPD was awarded funding to serve 1,950 program participants over six years, this will bring an associated \$4 million. HPD is one of nine project sites selected across the country. This award augments <i>Housing Choice</i>: HPD’s mobility counseling program that started as a pilot in 2018 and was expanded through Enterprise funding in 2021. The Community Choice Demonstration allows for a fully implemented mobility counseling program that will last through 2027.</p> <p>The Community Choice Demonstration will serve approximately 150 new families and will work primarily with families already assisted in the <i>Housing Choice</i> Voucher program who have children under 13. HPD will expand eligibility to include families with children under 18 if there are not enough eligible households with children under 13. HPD’s rental subsidy administration team and its Research and Evaluation team will partner with HUD and Abt. Associates for the randomized control trial study of the program. HPD’s application was informed by lessons learned from <i>Housing Choice</i>, HPD’s pilot. The program is designed to address the barriers that prevent participants from exercising their choice in accessing units in competitive, amenity rich neighborhoods. Key features of <i>Housing Choice</i> include tenant support, owner support, and exception payment standards through three phases of participation (pre-move, housing search, and post-move). This includes workshops, financial counseling, transportation costs, security deposits, owner bonuses, brokers’ fees, moving costs, and case management. <i>Housing Choice</i> uses exception payment standards in ZIP Codes with low rates of crime, low rates of poverty, and/or more well-resourced schools. Many of these program features have been included in the Demonstration.</p> <p>HPD is collaborating with NYCHA, the Continuum of Care and the NYC Department of Social Services and other New York City agencies and partners to administer 7,800 Emergency Housing Vouchers. HPD is providing housing search assistance through broker’s fees, a one-time payment to the owner and housing navigation support through either City agencies or contracted community-based organizations that offer housing navigator support.</p>

- D.1 Capital Improvements.** In order to comply with this requirement, the PHA must reference the most recent HUD approved Capital Fund 5 Year Action Plan. PHAs can reference the form by including the following language in Section C. 8.0 of the PHA Plan Template: "See HUD Form 50075.2 approved by HUD on XX/XX/XXXX."
