Nationwide, child support lifts an estimated **1 million** children out of poverty each year.

**\$639.7 M** (\$639,721,448)

**92%** of all the money collected goes directly to families.

**345,507** Children under 21 on the NYC OCSS caseload.

**74%** Percentage of cases with support orders as compared with the total caseload.  
Once an order is established, OCSS can begin to collect child support.

**82%** Percentage of children on the OCSS caseload who are born to unmarried parents and for whom paternity has been established.

**\$8,184** Average amount collected per family for accounts receiving payments.

Reduced **\$275K** debt owed to DSS since 2009.

Referred **5,152** NCPs to employment programs since 2013.

Offered **130** Child Support Information sessions with Training Institute since 2015.

Released over **50** YouTube videos.

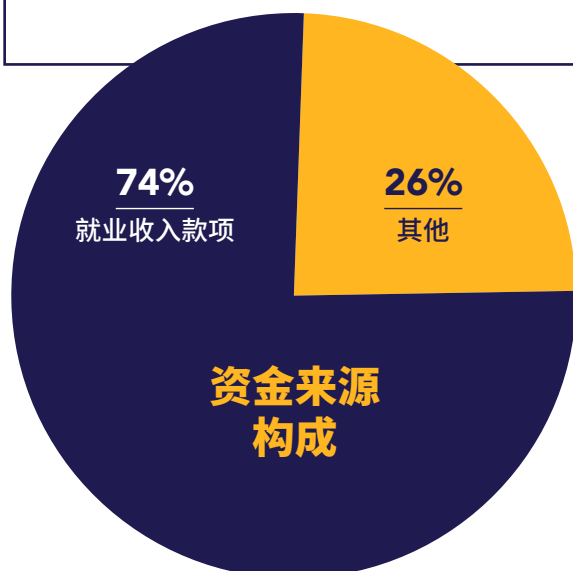
