WHEREAS, the Parties now wish to exercise their third option to renew the Agreement under the same terms and conditions except as modified herein;

NOW, THEREFORE, the Parties have agreed and do agree as follows:

- 1. Pursuant to the terms of the Agreement, the Parties exercise their right and option to renew the Agreement and hereby renew the Agreement for the period from January 1, 2019, until December 31, 2019, unless sooner terminated pursuant to the terms of the Agreement.
- Except as expressly amended by this Third Renewal, the terms and conditions of the Agreement and any modifications and Renewals thereto remain unchanged and in full force and effect.
