WHEREAS, the Parties entered into an Memorandum of Understanding ("the MOU") whereby Contractor allowed the New York City Municipal Identification Card ("IDNYC") Program to operate from and engage with applicants at the following DOF locations: Bronx Business Center at 3030 Third Avenue, 2nd Floor, Bronx, NY 10455; Brooklyn Business Center at 210 Joralemon Street, Brooklyn, NY 11201; Manhattan Business Center at 66 John Street, Manhattan, NY 10038; and Staten Island Business Center at 350 St. Marks Place, Staten Island, NY 10301; and

WHEREAS, the term of the MOU was from November 1, 2014 through December 31, 2016, with the option to renew for three (3) additional, consecutive one-year terms at HRA's option with the consent of DOF; and

WHEREAS, the Parties now wish to exercise their first option to renew the MOU under the same terms and conditions except as modified herein;

NOW, THEREFORE, the Parties have agreed and do agree as follows:

- 1. Pursuant to the terms of the MOU, the Parties exercise their right and option to renew the MOU and hereby renew the MOU for the period from January 1, 2017, until December 31, 2017, unless sooner terminated pursuant to the terms of the MOU.
- 2. Except as expressly amended by this First Renewal, the terms and conditions of the MOU and any modifications and Renewals thereto remain unchanged and in full force and effect.
