

Cash Assistance Work Requirements

IF YOU RECEIVE CASH ASSISTANCE BENEFITS, AND:

- You are between the ages of 18 and 59
- You are not caring for an incapacitated household member
- You do not have a physical or mental condition that prevents you from participating in work activities

Then you will need to participate in approved work activities to receive your benefits.

WHAT DOES THIS MEAN?

You will need to spend a certain amount of time each week working, looking for work, or participating in another approved activity such as education, training, or community service.

The number of required hours depends on your household and individual situation. HRA will inform you of your required weekly hours.

HOW CAN I MEET THIS REQUIREMENT?

If you are not currently working, HRA will refer you to a Career Services provider to discuss career goals and connect you with work, education, or training opportunities.

If you are already working, or believe you have a physical or mental condition that prevents you from working, please tell HRA and provide documentation.

If you receive an appointment related to work requirements, be sure to attend or provide a valid reason why you cannot.

If you have a child under 13, or under 19 with special needs, HRA can pay for child care so you can meet the requirement.

Failure to participate in required work activities may result in reduced or discontinued benefits and may affect eligibility for certain housing vouchers.

Si ou pa ap travay kounye a, HRA ap voye ou bay yon founisè Career Services pou diskite sou objektif karyè epi konekte ou ak opòtinite travay, edikasyon, oswa fòmasyon.

Si ou deja ap travay, oswa ou kwè ou gen yon kondisyon fizik oswa mantal ki anpeche ou travay, tanpri di HRA epi bay dokimantasyon.

Si ou resevwa yon randevou ki gen rapò ak egzijans travay yo, asire ou ale oswa bay yon rezon valab poukisa ou pa kapab.

Si ou gen yon timoun ki gen mwens pase 13 an, oswa ki gen mwens pase 19 an ak bezwen espesyal, HRA ka peye pou gadri pou ou ka satisfè egzijans lan.

Si ou pa patisipe nan aktivite travay obligatwa yo, sa ka lakòz benefis yo diminye oswa sispann, epi sa ka afekte kalifikasyon pou sèten bon lojman.
