Noncustodial Parents Received More than \$900,000 in Debt Reduction through 2022 Pay It Off

From October 17–31, we ran the eighth iteration of our timelimited debt-reduction program Pay It Off.

This year's program matched payments of more than \$500 with an equal reduction in arrears owed to the New York City Department of Social Services (NYC DSS) up to the total amount they owe in NYC DSS debt.

The 223 noncustodial parents who participated this year paid a total of \$457,500 and will see their child support debt lowered by over \$900,000—more than doubling the total payment amount.

While most of the money collected goes to lowering NYC DSS debt, almost a third of it—about \$131,000—will go to the custodial parents on these cases, in keeping with federal and state child support distribution requirements.

To participate, parents also had to have paid their current support payments in October, likely leading to additional payments that went directly to supporting children.

The Arrears Credit Program Bonus

In addition to matching Pay It Off payments, the program also encourages eligible noncustodial parents to participate in our Arrears Credit Program, which reduces NYC DSS debt by \$5,000 per year for every year of full and on-time child support payments. Parents can participate for up to three years, potentially receiving \$15,000 in debt reduction.

The 77 Pay It Off participants who signed up for the Arrears Credit Program received \$1,000 credit each, generating a total of \$68,934 in additional debt reduction just for signing up. If those parents successfully participate in the Arrears Credit Program for a year, combined they could earn as much as \$385,000 in additional reductions to debt owed to NYC DSS.

An Unprecedented Increase

This year's program also saw an unprecedented increase in the average payment associated with each Pay It Off agreement.

In 2021, the average payment per agreement was \$1,010. This year, it was \$1,947—a 93% increase, by far the largest jump we have ever seen from one iteration of the program to another.
