

SNAP Work Requirements

If you receive SNAP benefits, you may need to meet work requirements to continue receiving them. In general, children, older adults, and people with disabilities are exempt from work requirements. Participation in education, training, or treatment programs may also satisfy work requirements. HRA reviews each case individually and will inform you if work requirements apply to you.

You may need to meet additional work requirements if you are an Able Bodied Adult Without Dependents (ABAWD).

WHAT IS AN ABAWD?

If you are aged 18-64, and you do not live with a child under 14 in your household, are not pregnant or caring for someone who cannot take care of themselves, and do not have any physical or mental barriers to employment, you will probably need to meet ABAWD requirements.

WHAT ARE GENERAL SNAP WORK REQUIREMENTS?

Tell HRA about your employment status and availability to work. If you are working, do not voluntarily quit or work less than 30 hours a week without a good reason (such as being sick).

If you are not working and you receive a suitable job offer, you will need to accept it unless there is a good reason you can't. Also, you will need to participate in a SNAP Employment & Training program if one is assigned to you.

WHAT ARE ABAWD REQUIREMENTS?

If you are an ABAWD, you will need to work or participate in an approved work program, such as a SNAP Employment & Training program, for at least 80 hours per month. You can meet this through a combination of work and program hours, and through approved alternative activities.

You can also meet ABAWD requirements by participating in a work experience activity or community service. The number of required hours is based on your SNAP benefit amount divided by the minimum wage.

If you are already working, or believe you have a physical or mental condition that prevents you from working, please tell HRA and provide documentation. If you are unable to work at least 20 hours per month because of a physical or mental health condition, you can have a medical or clinical provider complete a simple form available on the HRA website.

If you receive an appointment for meeting work requirements, be sure to attend or provide a valid reason why you cannot.

Failing to meet the ABAWD requirements for more than 3 months over a 3-year period may result in a loss of your SNAP benefits.

Kondisyon pou Travay Pwogram Asistans Nitrasyonèl Siplemanè (Supplemental Nutrition Assistance Program, SNAP) yo

Si ou resevwa benefis SNAP, ou ka bezwen satisfè kondisyon travay pou ou kontinye resevwa yo. An jeneral, timoun, granmoun aje, ak moun ki gen andikap yo egzante de kondisyon travay. Patisipasyon nan pwogram edikasyon, fòmasyon, oswa tretman ka satisfè kondisyon travay yo tou. Administrasyon Resous Imèn (Human Resources Administration, HRA) revize chak dosye endividyèlman epi li ap fè ou konnen si kondisyon travay yo aplike pou ou.

Ou ka bezwen satisfè kondisyon travay siplemanè si ou se yon Granmoun ki an sante san depanan (Able Bodied Adult Without Dependents, ABAWD).

KISA YON ABAWD YE?

Si ou gen 18-64 an, epi ou pa ap viv ak yon timoun ki gen mwens pase 14 an nan gwoup fanmi ou, ou pa ansent ni ou pa ap pran swen yon moun ki pa kapab pran swen tèt li, epi ou pa gen okenn baryè fizik oswa mantal ki anpeche ou travay, pwobableman ou ap bezwen satisfè kondisyon ABAWD yo.

KI KONDISYON TRAVAY JENERAL SNAP YO YE?

Di HRA estati travay ou ak disponiblite ou pou travay. Si ou ap travay, pa kite travay la volontèman ni pa travay mwens pase 30 èdtan pa semèn san yon bon rezon (tankou si ou malad).

Si ou pa ap travay epi ou resevwa yon òf travay ki apwopriye, ou ap bezwen aksepte li sof si gen yon bon rezon ki fè ou pa kapab. Epitou, ou ap bezwen patisipe nan yon pwogram SNAP Employment & Training si yo mete youn sou ou.



Pou jwenn plis enfòmasyon, eskane kòd QR la.

KI KONDISYON ABAWD YO YE?

Si ou se yon ABAWD, ou ap bezwen travay oswa patisipe nan yon pwogram travay ki apwouve, tankou yon pwogram Travay ak Fòmasyon SNAP, pou omwen 80 èdtan pa mwa. Ou ka satisfè sa atravè yon konbinezon èdtan travay ak èdtan pwogram, epi atravè aktivite altènatif ki apwouve.

Ou ka satisfè kondisyon ABAWD yo tou lè ou patisipe nan yon aktivite eksperyans travay oswa sèvis kominotè. Kantite èdtan yo mande a baze sou kantite benefis SNAP ou divize pa salè minimòm nan.

Si ou deja ap travay, oswa ou kwè ou gen yon kondisyon fizik oswa mantal ki anpeche ou travay, tanpri di HRA epi bay dokiman sipò. Si ou pa kapab travay omwen 20 èdtan pa mwa poutèt yon kondisyon sante fizik oswa mantal, ou ka fè yon founisè swen sante oswa klinik ranpli yon fòm senp ki disponib sou sitwèb HRA a.

Si ou resevwa yon randevou pou satisfè kondisyon travay yo, asire ou ale oswa bay yon rezon valab poukisa ou pa kapab.

Si ou pa satisfè kondisyon ABAWD yo pandan plis pase 3 mwa nan yon peryòd 3 ane, sa ka lakòz ou pèdi benefis SNAP ou yo.
