OVERVIEW

The New York City Law Department is responsible for all of New York City's legal affairs. The Corporation Counsel, who is appointed by the Mayor and confirmed by the City Council, heads the Law Department and acts as legal counsel for the Mayor, the City Council, Citywide elected officials, and City agencies. Attorneys represent New York City on affirmative and defensive civil litigation, legislative and legal issues, the prosecution of juvenile delinguency matters, and Administrative Code enforcement proceedings brought in Criminal Court. With offices in all five boroughs and Kingston, New York, the Law Department handles an active caseload of over 70.000 lawsuits and legal matters each year. In addition to litigation, attorneys draft and review local and state legislation, approve leases, contracts and financial instruments for the sale of municipal bonds. They also negotiate and structure business transactions, advise on ethics and compliance matters, assess risk management strategies to help make the City safer. In addition, they provide legal counsel to City officials on a wide range of issues, such as immigration, education, judicial selection reform, and environmental policy.



- In-House Firm Program




TRIAL PROGRAM

A team of experienced attorneys from a law firm steps in as trial counsel for the Law Department. Once discovery is complete and settlement is unlikely, the law firm volunteers can step in and handle all aspects of the trial. Law firms have successfully handled trials for the Public Service Program both in the Tort Division and Labor & Employment Division, and trials may become available both in State and Federal court.

DEPOSITION PROGRAM

Volunteer associates obtain hands-on experience conducting depositions for our division's borough offices. Associates garner invaluable skills while both taking and defending depositions in personal-injury actions involving various City agencies. Deposition schedules can be tailored to meet each firm's needs.



IN-HOUSE FIRM PROGRAM

Firms take newly filed matters in-house, giving partners and associates the chance to handle cases from inception to disposition. This includes participation in depositions, motion practice, court conferences, settlement negotiations, and, ultimately, trials. Cases handled have ranged from premises liability and personal injury claims to allegations of civils rights violations and labor and employment litigation. Cases include Federal class actions pertaining to City policies. Class-action lawsuits have also been available for take-over via the In-house Firm Program.
