


BMCR | Project Status

ALL WORK IS SUBJECT TO CHANGE

- 1. Robert F. Wagner Place: Interceptor Gate Building and floodwall construction
- 2. South Street (Robert F. Wagner Place to Market Slip): Utility work, Catherine Slip temporarily closed for safety during pile installation
- 3. South Street (Market Slip to Montgomery St.): Utility work
- 4. South Street and Montgomery Street: work to begin in July, formal advisories to come

- 5. **Esplanade:** Installation of flip up gates, floodgate drainage, micropiles, trunk water main, and landscaping foundations
- 6. Pier 35: Floodwall construction, drainage modification, and micropile installation Pedestrian access via esplanade (closest entry from South Street is at Rutgers Slip)






Weekly Bulletins & Advisories are issued with construction activities. Saturday work and off-hour shifts are anticipated for some work operations.




BMCR | Flip Up Gate Progress

- 597 of 730 micropiles for floodgate foundations in place
- **514 of 1,830** linear feet of concrete floodwalls installed



Flip up gate in closed position – March 2025






