MINUTES OF PUBLIC MEETING New York City Loft Board Public Meeting Held at 22 Reade Street, 1st Floor Spector Hall

May 16, 2013

The meeting began at 1:13 p.m. The attendees were Gina Bolden-Rivera, Public Member; Chief Ronald Spadafora, Fire Department Representative; Chuck Delaney, Tenants' Representative; Daniel Schachter, Public Member; Mark Foggin, Manufacturing Representative; and Chairperson LiMandri.

INTRODUCTION

Chairperson LiMandri introduced himself and welcomed those present to the May 16, 2013 public meeting of the New York City Loft Board.

VOTE ON APRIL 18, 2013 MINUTES

Motion: Mr. Schachter moved to accept the April 18, 2013 minutes. Ms. Bolden-Rivera seconded the motion.

REPORT OF EXECUTIVE DIRECTOR

Ms. Alexander presented two buildings statistics summaries: the milestones reached by all IMD buildings and the milestones reached broken down by §281(1)(4) and §281 (5) buildings:

- The summary of milestones reached by all 329 buildings in the Loft Board's jurisdiction was as follows:
 - 34 buildings obtained a certificate of occupancy with 19 pending removal applications and 15 that have no removal application pending;
 - 96 buildings with either a temporary certificate of occupancy or 7-B certification; 32 having a TCO and 64 with a 7-B certification;
 - 104 buildings were in the permit stage;
 - 58 buildings were in the narrative statement process: 18 had received certification and 40 were still in the process; and
 - There were 6 buildings with alteration type 1 filings; and
 - There were 31 buildings that had not filed an alteration type 1 as of yet.
- The second summary broke down § 281(1)(4) and § 281 (5) buildings as follows: There are 259 § 281(1)(4) buildings and 70 § 281(5) buildings.
 - Of the 34 buildings that had obtained a certificate of occupancy at set forth above, all were § 281(1)(4) buildings. None of the § 281 (5) buildings had reached this milestone;
 - Of the 96 buildings with either a temporary certificate of occupancy (TCO) or 7-B certification: 30 of the § 281(1)(4) and 2 of the §281(5) had a TCO; and 63 of the § 281(1)(4), and 1 of the § 281(5) buildings had 7-B certification;
 - Of the 104 buildings with permits: 100 were § 281(1)(4) buildings, and 4 were § 281(5) buildings;

- Of the 58 buildings in the narrative statement process: 16 of the § 281(1)(4) buildings and 2 of the § 281(5 buildings had received certification, and 14 of the § 281(1)(4) and 26 of the § 281(5) buildings were still in the narrative statement process; and
- There were 6 § 281(5) buildings with alteration type 1 filings; and
- There were 2 § 281(1)(4) buildings and 29 § 281(5) buildings that had not filed an alt 1 as of yet.

Ms. Alexander also told the Board that out of the 70 §281 (5) buildings registered with the Loft Board.

- 55 buildings are in Brooklyn;
- o 14 buildings are in Manhattan; and
- 1 building is in Queens.
- Of the 329 buildings in the Loft Board's jurisdiction there are a total of 70 IMD buildings in Brooklyn. Twenty-five are 281(1)(4) buildings and 55 are 281(5) buildings.

Ms. Alexander reported that the five-year report was being worked on by the DOB communications and design team and should be ready soon for Board review.

Ms. Alexander announced that there was no longer a backlog of applications and that every application that was post answer had been sent to OATH.

Regarding the Hearing Unit's statistics, **Ms. Alexander** reported that:

- There are 311 cases pending: 217 coverage applications and 94 non-coverage cases.
- Of the 94 non-coverage applications:
 - o 3 are appeals of determination;
 - o 1 is an alternate plan application;
 - o 14 are extension applications;
 - 1 is a landlord-initiated rent dispute;
 - 7 are abandonment applications;
 - o 6 are landlord initiated contests of coverage.
 - o 22 are removals,
 - o 3 are challenges to proposed Sales of Improvements;
 - 1 is an unreasonable interference application;
 - 3 are access applications;
 - 1 is for reconsideration;
 - 3 are code compliance rent adjustment applications;
 - 4 are tenant initiated rent dispute;
 - o 2 are prime lessee compensation for improvements applications;
 - 8 are harassment applications;
 - o 9 are diminution of service applications; and
 - o 6 are non-compliance with code compliance deadline applications.
- Of the 311 cases;
 - 44 are non-OATH cases;
 - 3 are administrative appeals:
 - 3 are rent adjustment applications;
 - 19 are removal cases;
 - 14 are extension applications; and
 - 1 is a reconsideration application.
- 222 cases are in the Administrative process:
 - 29 are pre-OATH cases;
 - 8 are incomplete/defective; and
 - 21 cases are in the answer period.
- 109 are OATH cases:
 - 17 non-coverage cases; and
 - 92 coverage cases.

Ms. Alexander also reported that OATH had returned 84 cases.

- Twenty-nine of the returned cases were master cases:
 - 3 are abandonment applications;
 - o 3 non-compliance with code compliance deadline applications;
 - 1 alternate plan application;
 - 19 coverage applications;
 - o 2 rent dispute applications; and
 - 1 challenge to Proposed Sales of Improvements.
- Fifty-five of the returned cases were summary cases:
 - 48 coverage applications;
 - 1 access applications;
 - 1 landlord initiated rent dispute applications;
 - 1 challenge to proposed sale of improvements;
 - o 3 landlord initiated contest of coverage applications; and
 - 1 diminution of service application.
- There are 3 currently in litigation;
- 4 applications are part of a conference by the Loft Board staff; and
- 42 applications are on the May 16th agenda.
