

**DRAFT MINUTES OF PUBLIC MEETING

**INTRODUCTION**

**REPORT OF EXECUTIVE DIRECTOR**

**Ms. Alexander** reported that there are a total of 314 buildings registered with the Loft Board. There are 36 A buildings; 14 with final LE's pending and 22 with certificates of occupancy but no LE's pending. There are 212 B buildings: 33 with TCO's; 72 with 7B compliance; and 4 with 100% of the work completed. There are 100 buildings with permits only and 3 that have returned to the Narrative Statement process. There were 44C buildings: 15 with Certifications but no permit and 29 with no Certification. There are 22 D buildings: 12 that have filed Alteration Application, and 10 that have not. There are 2 new registrations, bringing the total building count to 316 buildings.

**Ms. Alexander** reported that she and Mr. Delaney had discussed improvements to the Loft Board website and that she had contacted DOITT regarding the proposed changes.

He also reported that community outreach consisted of workshops, questions and answer sessions and distribution of a frequently asked questions flyer.
