PROJECT DESCRIPTION

714 MADISON AVENUE IS A FIVE (5) STORY COMMERCIAL BUILDING LOCATED IN MANHATTAN ALONG MADISON AVENUE .

THE BUILDING WAS CONSTRUCTED CIRCA 1871.

THE PROPERTY IS LOCATED WITHIN THE UPPER EAST SIDE HISTORIC DISTRICT, AS DESIGNATED BY THE NEW YORK CITY LANDMARKS PRESERVATION COMMISSION (LPC).

THE FACADE SCOPE OF WORKS CONSIST OF THE FOLLOWING:

1. INSTALL NEW AWNINGS AT 2ND, 3RD, 4TH AND 5TH FLOOR WINDOWS, SIMILARLY TO THE ADJOINING PROPERTIES. ADD WHITE LOGO AT AWNING SKIRTS AT 2ND AND 3RD FLOOR WINDOWS.








Existing & Proposed Facade Elevation






