## **14th Floor Windows**

- Historic windows were double hung windows with no divided lites
- **Existing windows are center pivoting windows with one single lite**
- **Proposed windows inswing casement windows with one single lite**
- Proposed windows differ from historic in order to maintain the aesthetic consistent throughout the building
- Proposed windows match LPC approved permits issued in both 2000 (PMW 00-5017) and 2006 (PMW 07-4136)




