Landmarks Preservation Commission Public Hearing

Summary of comments and changes

- Commissioners' comments: The angles of the rooftop and rear-yard additions do not respect the house's angles and create a discordant appearance.
 Response: The angles of the rooftop and rear-yard additions have been rationalized to be in alignment with the house.
- Commissioners' comments: The visibility of the mechanicals should be decreased.
 Response: The footprint of the mechanical enclosure has been decreased so that it is no longer visible from Greenwich St and Bank St.
- Commissioners' comments: Rear elevation features should be reconstructed.
 Response: The missing brick cornice is proposed to be reconstructed based on 92 Bank Street's. The top floor window lintels will be retained.




GREENWICH VILLAGE HISTORIC DISTRICT MAP




NYCITYMAP BLOCK PLAN
























