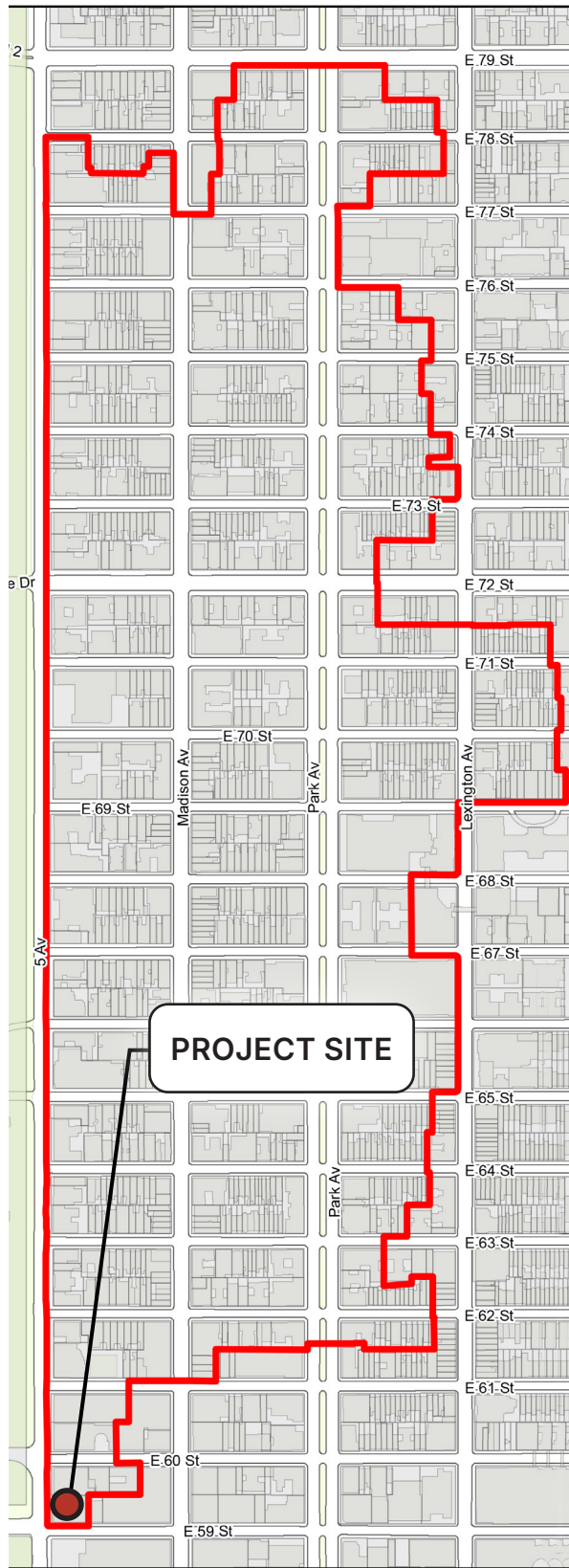

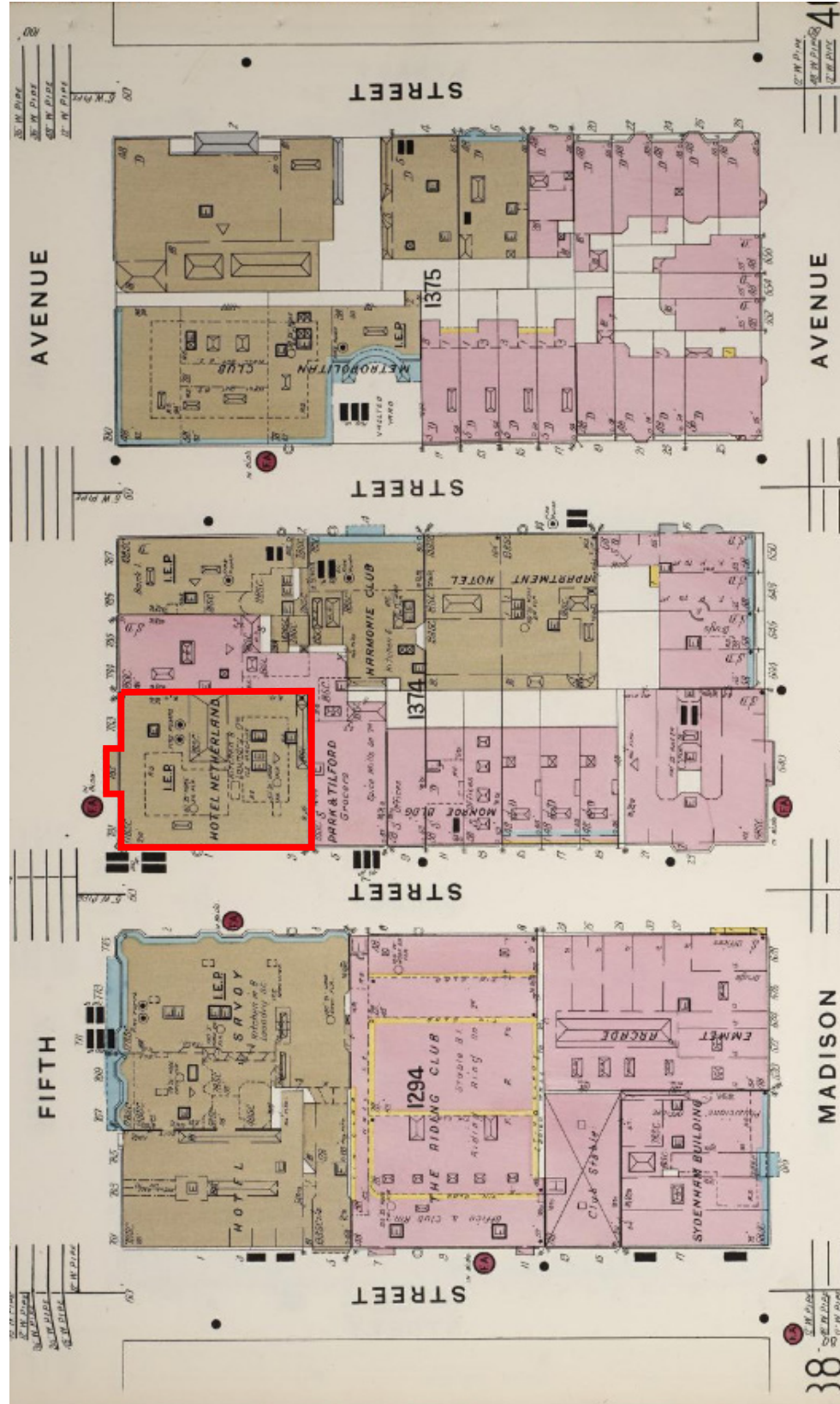

MAP OF UPPER EAST SIDE HISTORIC DISTRICT



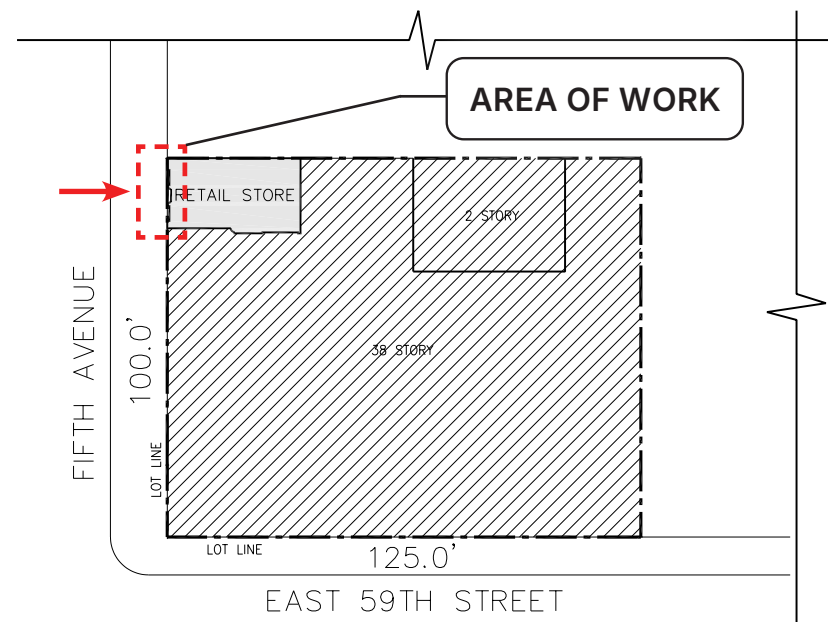

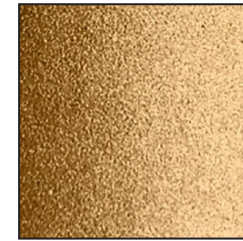

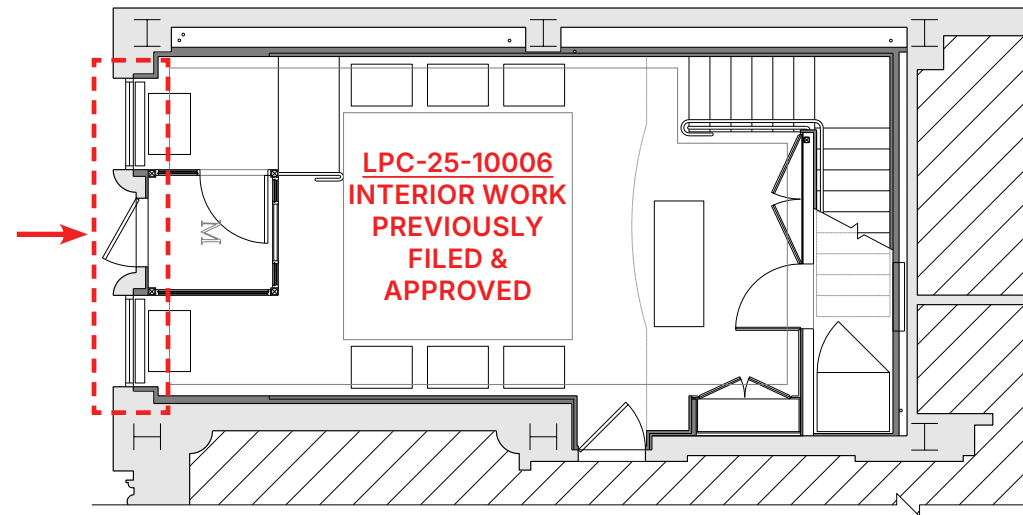

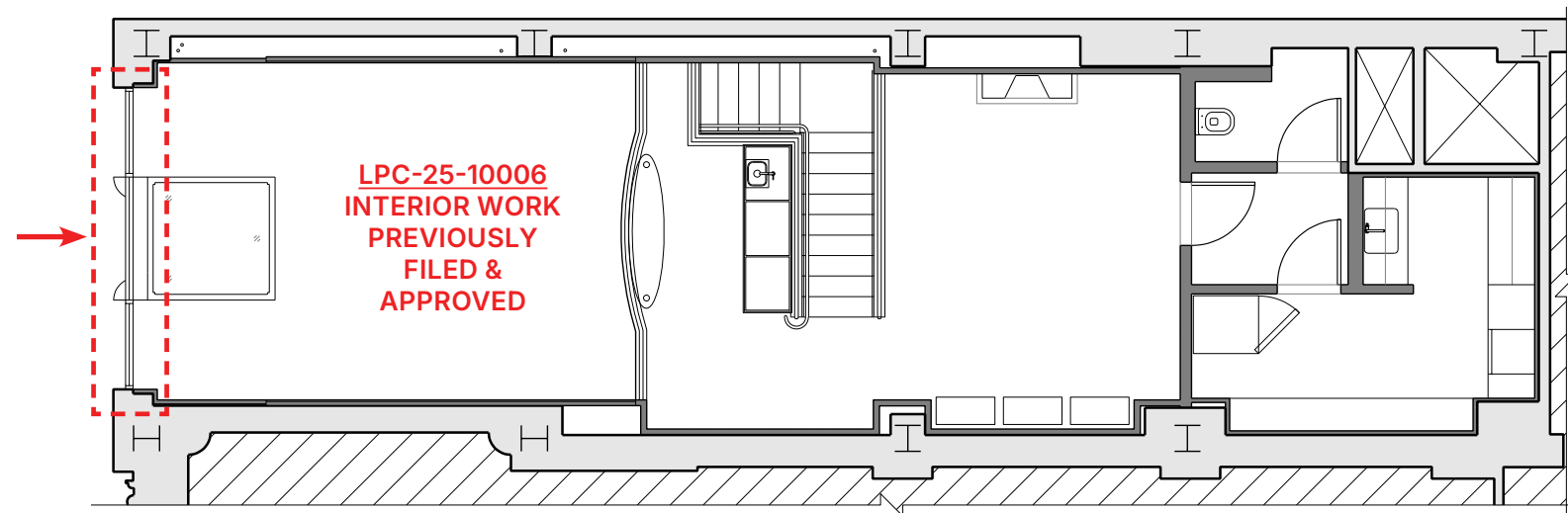

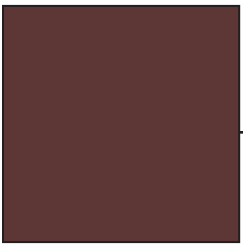

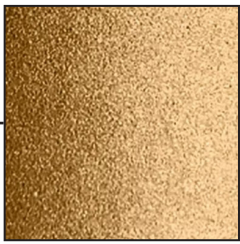

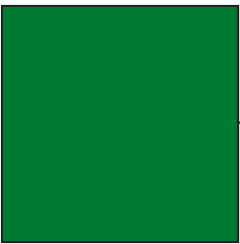

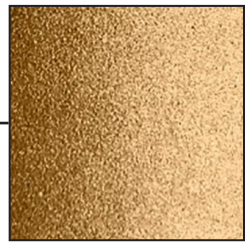

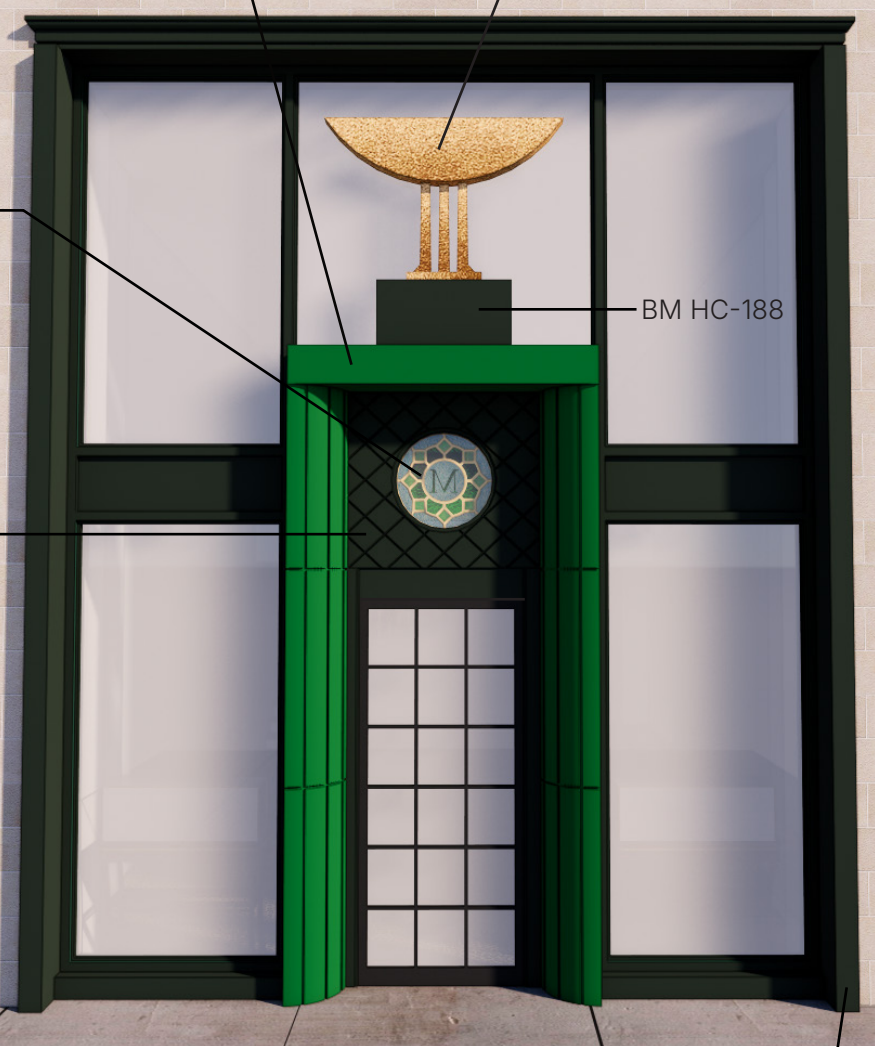

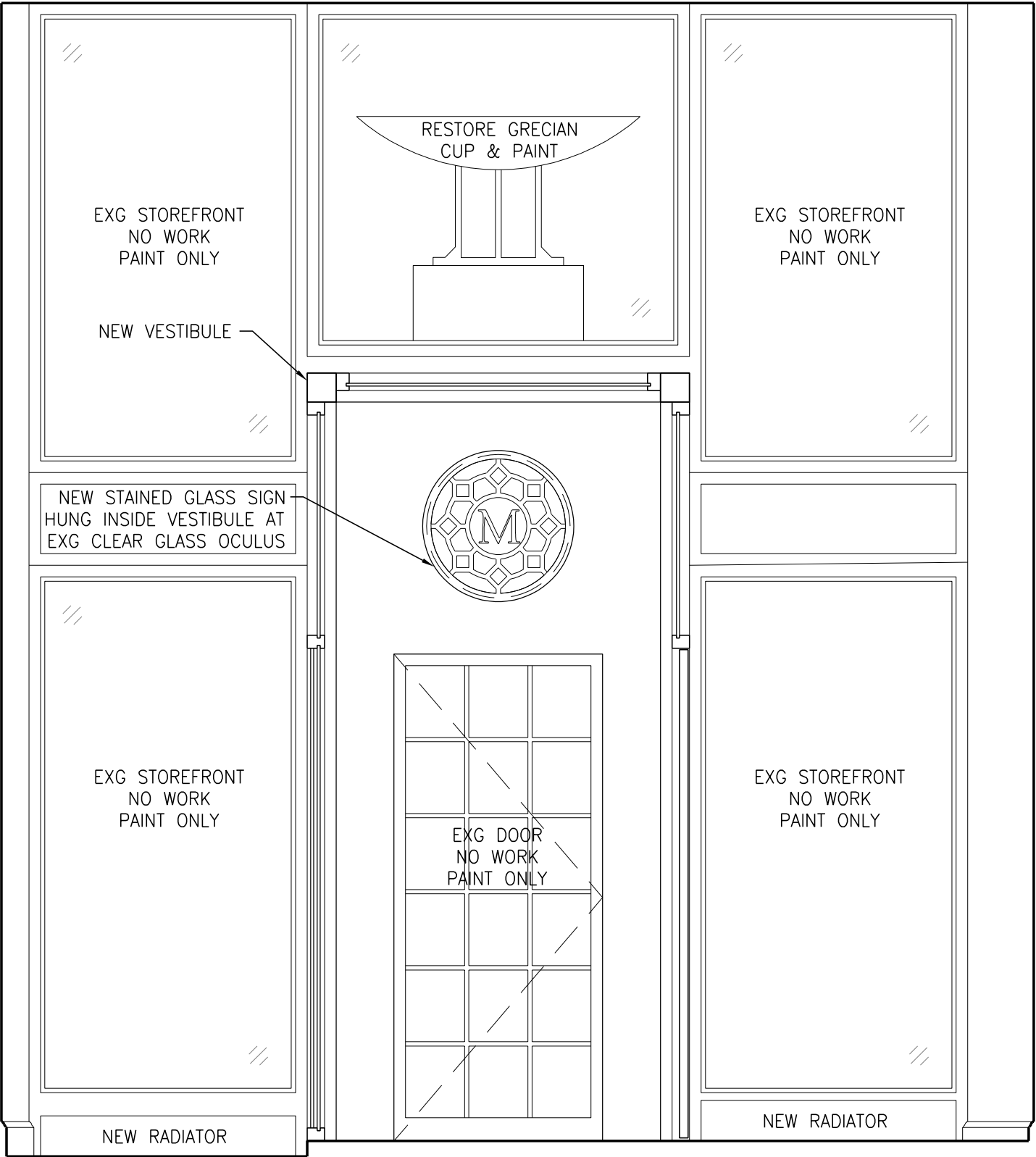

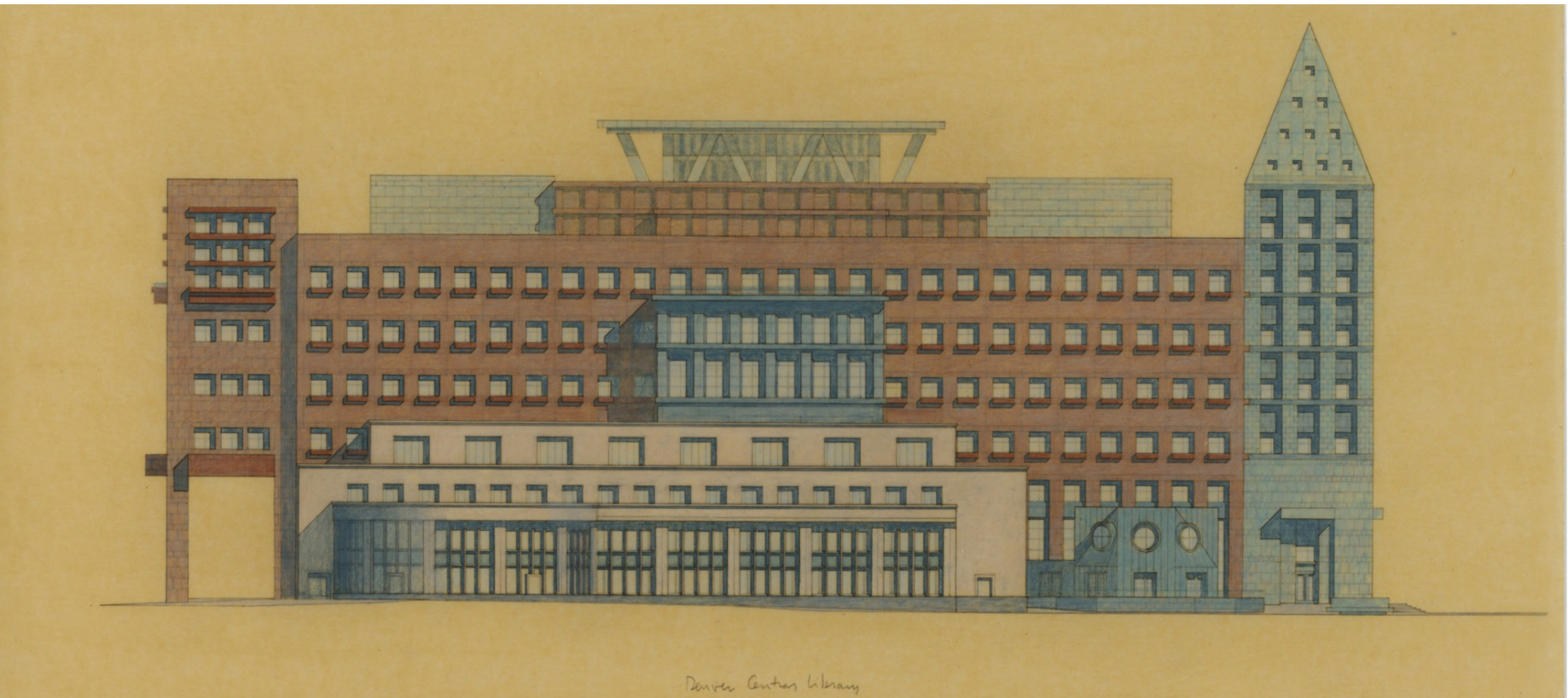
