



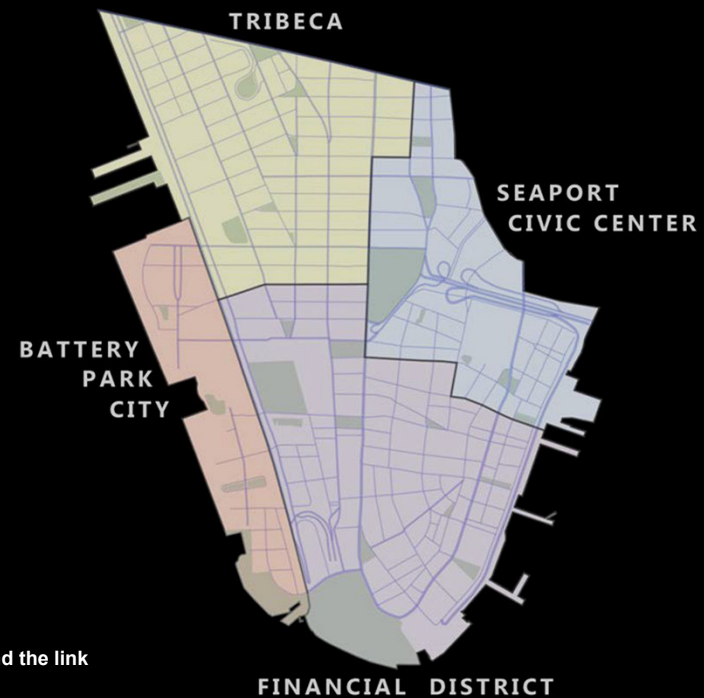

The notice shall be printed or highlighted in a pink ink of neon, luminous or fluorescent variety.

Notice of Renewal for an On Premises Liquor Establishment

Within 10 days after filing a renewal application (Date the application is mailed) with the Authority, notice must be posted of such filing. This notice **must** be posted in a conspicuous place at the entrance of the establishment and remain posted throughout the pending license application period. The notice shall be printed or highlighted in a pink ink of neon, luminous or fluorescent variety.

NYS SLA Posting Requirements

Notice of a 500 Foot Hearing

Within 10 days of the applicant's receipt of written notice (Date of hearing notice) of a 500 ft hearing, from the SLA, notice **must** be posted of such hearing. This notice must be posted in a conspicuous place at the entrance of the establishment and will remain posted until the date of the hearing specified on notice. This notice shall include in clear and concise language a statement of the use and capacity of the establishment. 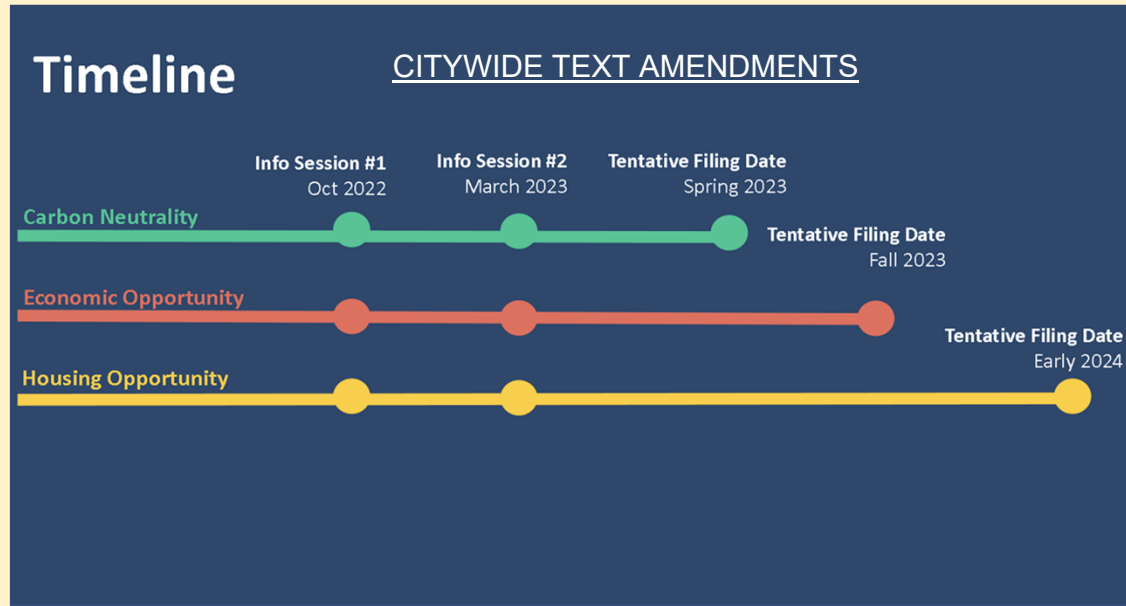

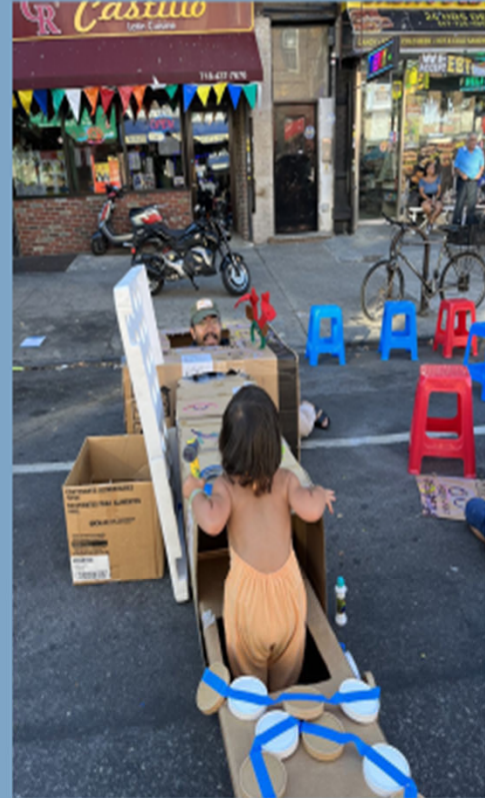

AHRC New York City, soon celebrating our 75th year, is a not for profit advocating for people with developmental disabilities.

Our **vision** is of a socially just world where the power of difference is embraced, valued, and celebrated.

We have over 150 locations around the five boroughs and **touch the lives of over 12,000 people and their families annually.**

Our headquarters building is located on **Maiden Lane, in the heart of the financial district**, since soon after 9/11.



AHRC New York City's Education Department has been a leader in education since the organization's founding in 1949.

Our schools were used by the NYC Board of Education to model their special education services in the 1950's and the first preschools for children with suspected disabilities were run by AHRC NYC long before the public law that made these services an entitlement.

Currently, we operate five highly successful preschools and three school age programs in the five boroughs. These services are funded by the New York State Education Department and in New York City, operate with the approval and oversight of the New York City Department of Education.

AHRC NYC is proposing to open a new State Approved preschool nursery serving children with disabilities between the ages of 3-5, placed by the NYC DOE, who reside in downtown Manhattan (Community Board 1) and within walking distance of the financial district.

Community Board 1 appears to be under-served or has unmet needs for this population.



Proposal

- The preschool would be located at our headquarters at 83 Maiden Lane, New York City 10038 on the 3rd floor and serve approximately 72 students (10 classes with a high adult to child ratio of 6:1:3 and 8:1:2).
- The program for preschool children with disabilities is tuition free as it is paid for by the NYSED and NYC DOE.
- AHRC NYC is also considering opening a few classes for children without disabilities who may be considered at risk for delay or deemed "immature."
- The children would receive all of the critical therapies and services as mandated by regulatory agencies.

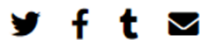

- Local deliveries
- Pick-ups and drop-offs
- Necessary City service vehicles, utility vehicles, and emergency vehicles

Alternate Side Parking

When Alternate Side Parking is in effect on an Open Street, vehicles should leave the street and may return after ASP is over.

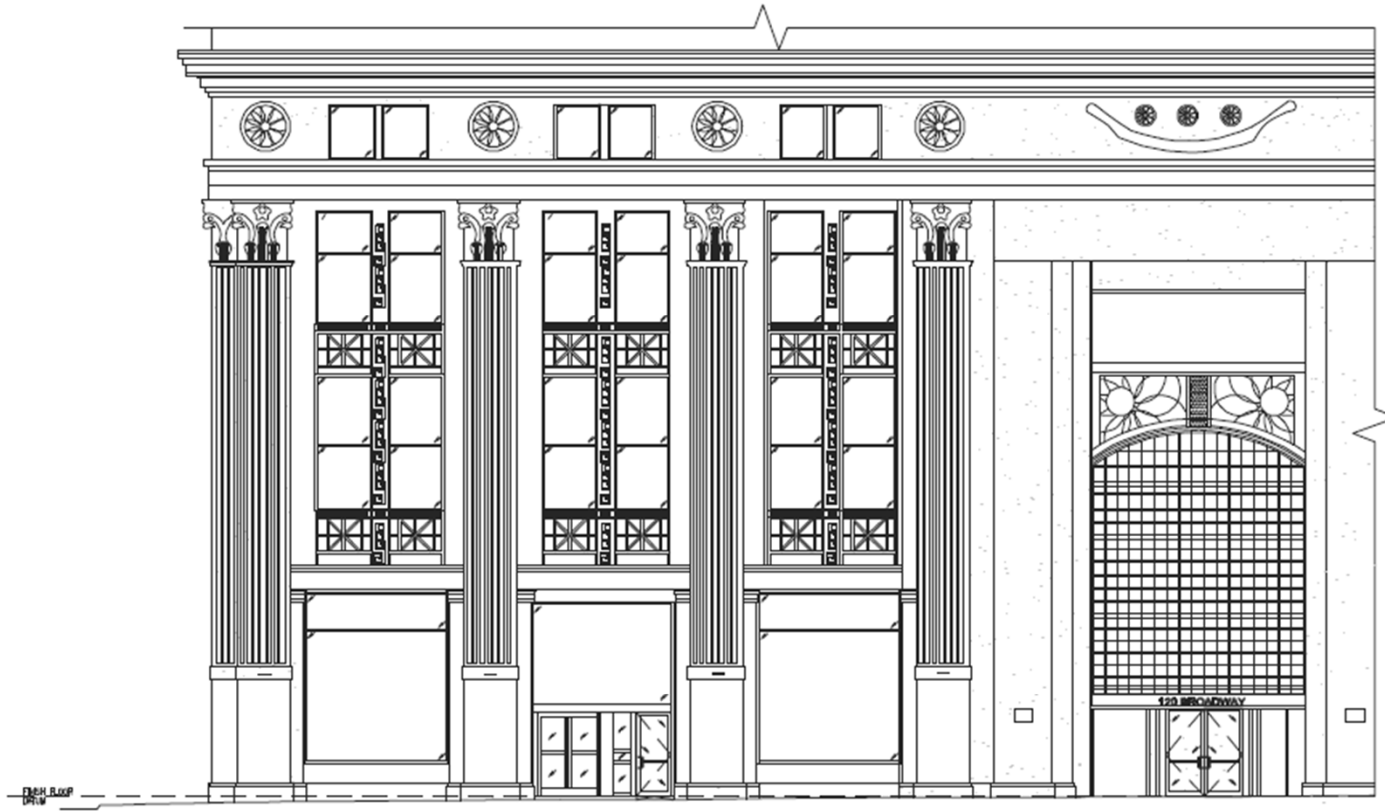
If barriers are in place, they should be set up in a way that cars can drive around them.

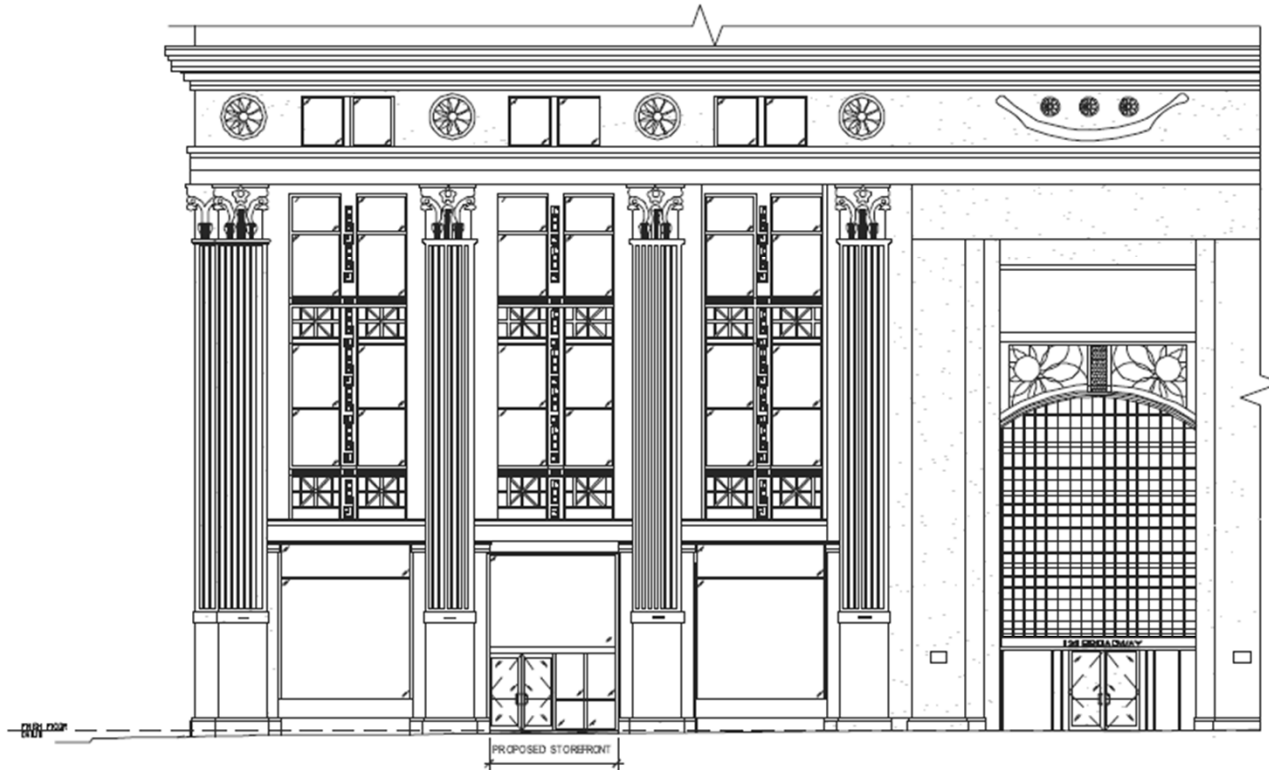
1 NORTHWEST ELEVATION (BROADWAY) - DEMOLITION ELEVATION

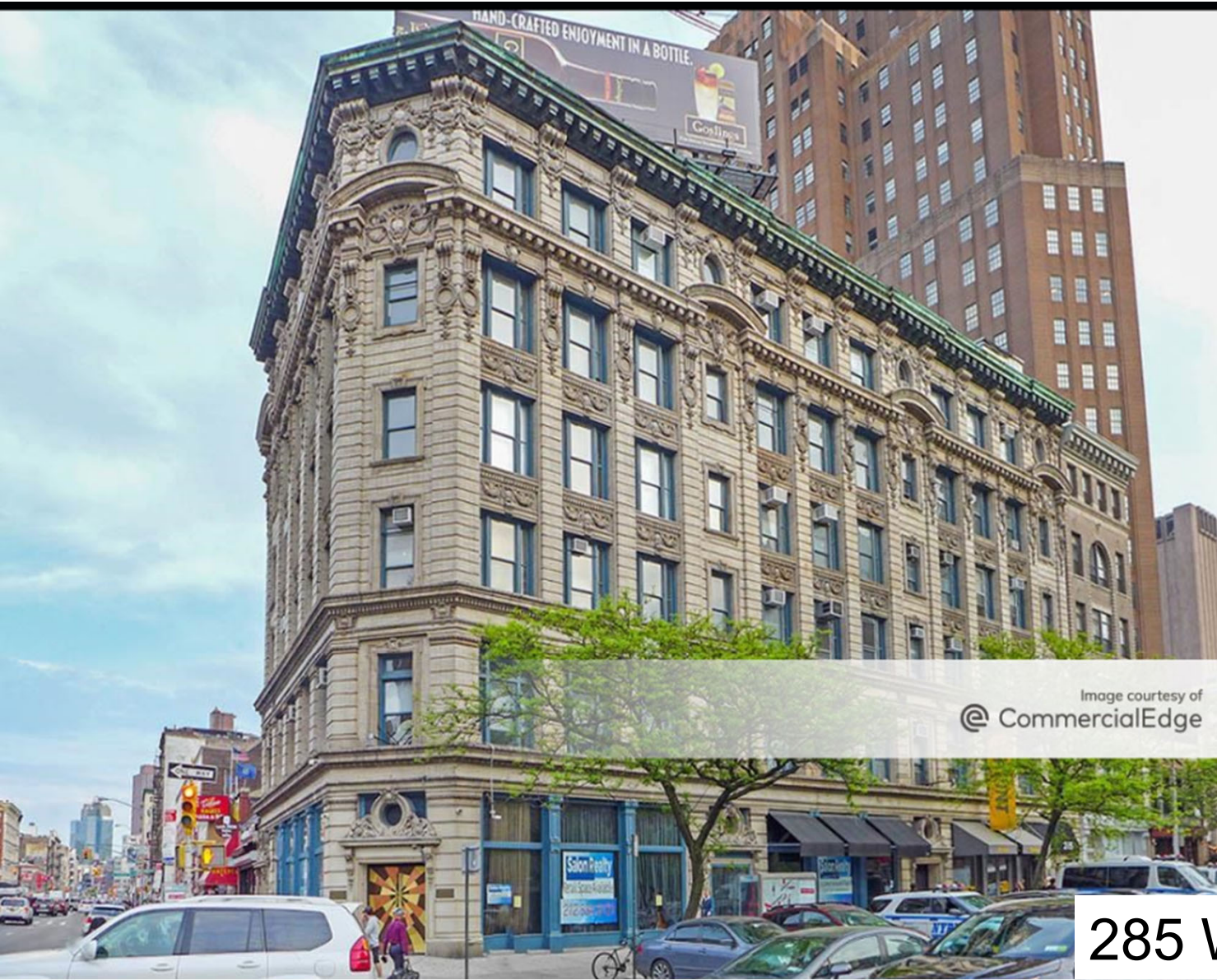

Start in the estuary.

- Existing natural systems must be preserved as we initiate innovative environmental interventions,
- expanding the current oyster restoration initiative,
- ecological enhancement of near-shore environments,
- wrap pier piles and surface the bulkhead with materials that encourage and support the growth of marine and terrestrial flora and fauna.

Improve water quality.

- In-water environmental enhancements won't succeed without substantially improving water quality;
- Stop the routine discharge from 33 combined sewer outfalls that dump untreated waste directly into the Hudson River
- The park's in-water property is designated as an estuarine sanctuary and these discharges wreak havoc on the marine and bird life and create unsanitary conditions for boaters and other park visitors.
- A 48-inch stormwater sewer line could capture and store stormwater to prevent its discharge and then slowly routed to a wastewater treatment plant after the rain event. NYC DEP issues bonds to build its water treatment facilities and should design and finance this critical type of infrastructure in the Hudson River Park.

Redesign Route 9A

- Almost 40 years ago the West Side Task Force recommended a surface boulevard but at that time, the future of the waterfront and the adjacent neighborhoods was unknown, and assumptions were made about what would take place on both sides of the roadway.
- But few envisioned the dramatic transformation of the Meatpacking District and Hudson Yards, redevelopment of Hudson Square, popular new attractions like the High Line and Little Island, or commercial offices at Pier 57.
- Development on both sides of the roadway has matured, both conventional biking and electric-powered micro-mobility have increased exponentially, and congestion pricing is expected to reduce Manhattan vehicular traffic below 60th Street by about 20 percent.
- Repurpose Route 9A's parking lane for micro-mobility would support the current and future use of electric bicycles and scooters and food delivery.
- The new \$1.2 trillion federal Infrastructure Investment and Jobs Act included \$110 billion to improve the nation's transportation infrastructure and could support the redesign.

Expand the park and use creative shore-based measures.

- Redesigning Route 9A could create an opportunity to expand the park, as well. If the roadway can be narrowed, the park and its bicycle path can be expanded, for more creative, and natural, shore-based flood-control measures.
- The tree-lined, 19-foot-wide median was designed to facilitate pedestrian safety and mitigate air and noise pollution from traffic.
- The anticipated 20 percent reduction in traffic from congestion pricing argues for a narrower roadway, while new vehicles are trending toward electric propulsion, which is quiet and has no exhaust emissions.
- With less traffic, one vehicle lane and the median might be removed from the roadway. That would add 30 feet of width to the Hudson River Park. Except perhaps in the section from 14th to 23rd Streets
- Expanding the park would provide room for creative, shore-based measures, such as 12-foot-high, reinforced landscaped berms to increase park elevations.

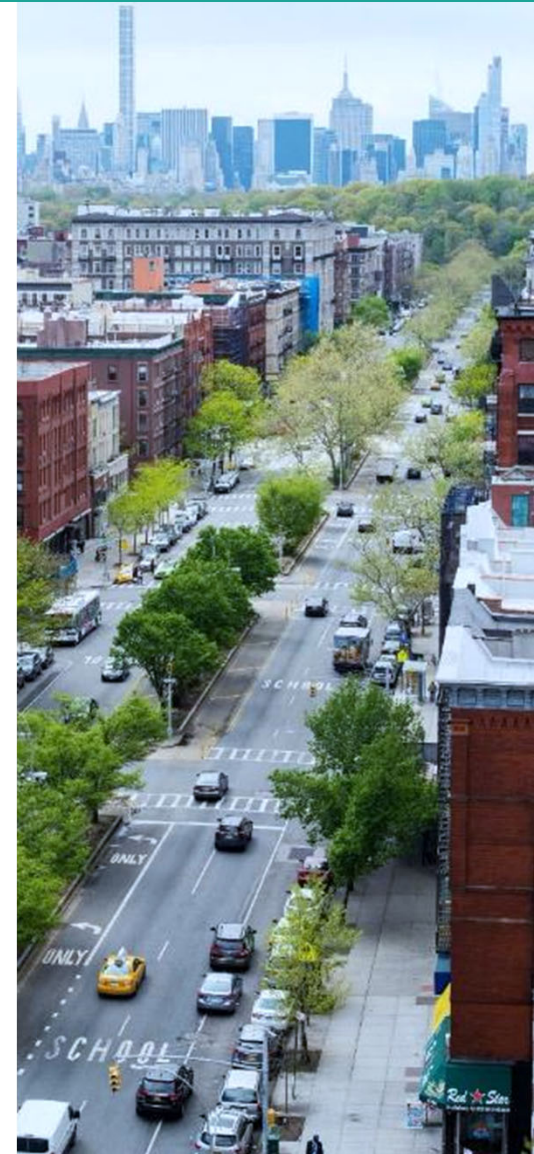
The proposed Task Force should be responsible for decision-making

- The same meaningful and transparent community participation that led to the creation of the Hudson River Park.
- Create a new vision to complete the metamorphosis of the West Side into the next century.
- Only the governor and mayor can assemble and empower senior level government, civic, business and community leaders to capture this opportunity.
- No one else can ensure that the Hudson River Park Trust, U.S. Army Corps, city Department of Environmental Protection, state Department of Environmental Conservation, the city and state Transportation Departments and other involved agencies coordinate their efforts.



What is NYC Accelerator?

- + A New York City program to help control costs, meet compliance requirements for local laws, boost building performance, increase energy savings, and reduce carbon emissions across New York City buildings. NYC Accelerator:
 - Provides **free technical guidance** to help the market transform how our buildings operate and are built
 - **Identifies building upgrade projects** to help meet emissions limits established under the Climate Mobilization Act and other local building energy laws
 - Offers **no-cost building operator trainings** and supports green workforce development
 - Connects building decisionmakers directly with **service providers** to implement decarbonization projects
 - Helps buildings identify **applicable financial incentives and financing**, such as NYC Accelerator PACE



Local Law 97 (LL97)

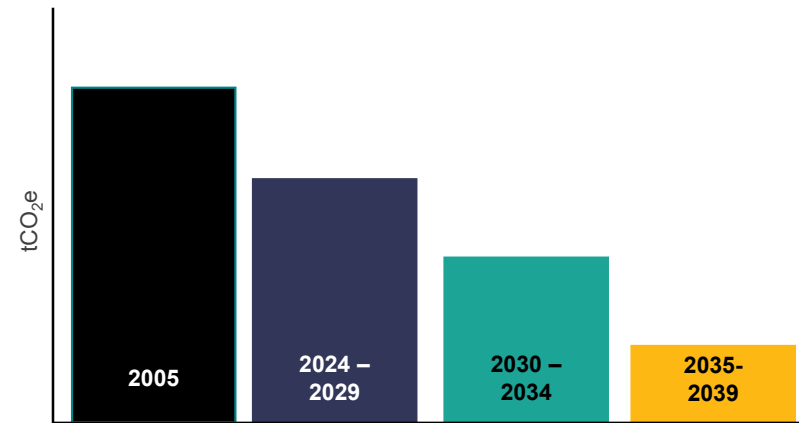
+ **Market Rate buildings >25,000 square feet** will meet ambitious carbon reduction targets

- First carbon emissions limit will be applied in 2024-2029
- Second carbon emissions limit will be applied in 2030-2034
- Lower limits will follow in 2035 and beyond to reach 80% reduction by 2050

Under existing conditions:

- 75%-80% of properties meet 2024-2029 LL97 limits
- 25%-30% of properties meet 2030-2034 LL97 limits
